On September 30. Madeleine Doubek of Reboot Illinois spoke to about 40 attendees the at first Chicago in Focus (CiF) event of this

program year. This series is co-sponsored by LWVChicago and the Union League Club.



Before founding Reboot Illinois Doubek was a political reporter and editor of the Daily Herald. The

Reboot Illinois web site features many news articles and provides links to many organizations.

Doubek emphasized that coping with problems at the state, county and city level are intertwined and the finances of all levels of government affect their ability to address social service needs and infrastructure. For too long, these governments have ignored financial realities. The 2008 recession aggravated problems but did not precipitate them.

Citizens should engage with events. Everyone should follow at least one source of news about government. Every citizen should call, email or write elected officials about concerns. It is important to be knowledgeable and clear on what the citizen wants the legislator to do. Doubek cited concerns of residents in the collar counties about rapidly rising property taxes which led to passage of tax cap legislation.

The focus of the luncheon will be the schools and the community. We are now working to secure the panel members and a moderator.

person and \$347.50 for each child under 18 years, whichever is higher. In Illinois enrollment in the ACA is handled by GetCoveredIllinois.

She developed materials explaining the election process in Chicago which were used in the development of the Election Judge Handbook and as part of an extensive pollwatching guide.

LWVUS Money in Politics Change in Schedule

At its October meeting the LWVChicago Board decided to change the scheduled January briefing to the LWVUS update (including consensus) on the position on campaign finance. This is for the purpose of addressing the lack of member understanding and agreement as to whether financing a political campaign is protected speech under the First Amendment.



The LWVUS campaign finance position will be updated through a study and consensus process to consider (1) the rights of individuals and organizations under the

First Amendment to express their political views through independent expenditures and the finance of election campaign activities and (2) how those rights, if any, should be protected and reconciled with the interests set out in the current position. The briefing on January 9 will address issues for this study.

Additional information may be found on the LWVUS web site and also will be provided in an article in the next Chicago Voter.

The current League position on campaign finance is: The League of Women Voters of the United States believes that the methods of financing political campaigns should ensure the public's right to know, combat corruption and undue influence, enable candidates to compete more equitably for public office and allow maximum citizen participation in the political process. This position is applicable to all federal campaigns for public office –presidential and congressional, primaries as well as general elections. It also may be applied to state and local campaigns.

Interviewing Chicago Aldermen

Recently, forty-two aldermen signed a resolution for a moratorium on new charter schools. Eight did not. Where does your alderman stand on this issue? And other issues? Make an appointment to visit your alderman and let him/her know that you care how they are voting.

To find contact information for your alderman and to set up an interview, check with the City of Chicago reference.

Please let the office know when you are visiting your alderman. If possible, plan your visit with another League member in your ward. To find other members who live in your ward, contact the office. Aldermen always like to talk to their constituents, and it might be easier to go to the interview as part of a team. Your alderman will have an office in the ward, and also in City Hall.

The primary purpose of interviewing your alderman is to strengthen communications and to make him/her aware of the League of Women Voters of Chicago – that we are an active participant in city government and we follow the activities of the City Council. Be prepared to discuss the purposes of LWV Chicago:

- To educate its members and the public to lobby government on selected issues,
- To observe the functioning of government bodies to monitor their accountability and transparency.
- To help the public understand how democratic government functions, and

• To educate the public about the election process by providing information about candidates and voting rights and procedures.

League in Your Neighborhood

On October 20, Krista Grimm, Vice President of the League of Women Voters Lake Michigan Region and Co-chair of the Water Committee for the Sierra Club Chicago, offered practical ways for ways that we, collectively and individually, can help reduce stormwater flooding. Her presentation, "Stormwater from the Ground Up" was given to League members and guests at the Sulzer Regional Library.



In addition to the specific actions to reduce flooding indicated in her presentation members should be aware of Illinois HB 2401 which would provide a ban on coal tar sealants. League is in support of this legislation; let your state representative know.

MWRD, October 15



MWRD will enter into a partnership with the City of Chicago to submit a grant to HUD to make green infrastructure improvements to capture stormwater and reduce the incidents of flooding in the West

Side Demonstration Area.

MWRD will enter into a similar partnership with Cook County that will include stormwater management project to address flooding issues in the south suburban pilot area.

The CTA Yellow Line will reopen by October 30.

Chicago Board of Education, Sept.29

Forest Claypool, President, reported that attendance on the first day of school was up to 94.8%.

Dr. Janice Jackson, the Chief Education Officer, reported that the district is committed to serving each special education student

as required by their Individual Educational Plan (IEP). Dr. Winston, from the Office of Diverse Learners gave a detailed report on the special education services. She stated that all special education students will receive services as it is the law. There are 71,000 students with IEP or 504 plans. About half of these students have average to above average IQ. The goal is to make more of them proficient or higher in reading and math. The special education budget is \$826 million. There are 2,928 fewer IEP students today than in June, 2015.

Alderman Scott Waguespack (32) and others protested the recent cuts to special education. Mr. Claypool asked for precise examples, saying that compliance with special education IEPs is sacrosanct. There was a group supporting the new Noble charter school in Bronzeville as well as a large group of community members against Noble. They said they have enough high schools and Noble will only take students from the traditional public schools in the neighborhood. There were several speakers, including **Rae Sokolow** from LWVChicago, who spoke requesting a moratorium on new charter schools until accountability measures are in place and the financial difficulties of the district are resolved.

In the last two meetings there has been new activity by aldermen, who as public officials are allowed to address the board first. They are speaking as advocates for or against proposed CPS activity in the schools in their wards. This would seem to portend a new level of interest on the part of the aldermen.

Chicago City Council Budget Hearing October 8



The Department of Family and Support Services was the subject of this City Council budget hearing. Lisa

Morison Butler, Commissioner, and her staff, answered the questions from aldermen.

This department has the following divisions: Children Services, Community Service Centers, Division on Domestic Violence, Homeless and Emergency Services, Policy and Advocacy, Senior Services, Veterans Resource Office, Workforce Development and Ex-Offender Programs and Youth Services.

The proposed 2016 budget for the DFSS is \$348,060,930 compared to \$348,226,516 appropriated for year 2015. This would provide for 403 employees, down from 516 employees in the current budget. Department staff explained that 76% of the expenses are sent to "delegate" agencies, such as Head Start and After School Matters. Greater funding will be made to these agencies, reducing the department's own employee count while keeping the total department budget flat.

Many aldermen expressed the need for funding services for the homeless throughout the City. Commissioner Butler said the latest "point-in-time" count showed Chicago had a 6,700 homeless population. She estimated that 19.4% suffer from mental illness and 22.7% have substance abuse problems. Furthermore, homeless individuals cannot be compelled to go to shelters or accept services. Butler said she is working closely with the Department of Public Health to reach them.
