WAIVER, RELEASE AND INDEMNIFICATION AGREEMENT

The undersigned adult ("Releasor" and "Participant") or parent or legal guardian ("Releasor") of a minor ("Participant") enters into this Waiver, Release and Indemnification Agreement ("Release") in favor of ENGLEWOOD AREA BOARD OF REALTORS®, INC, a Florida not-for-profit corporation, its owners, directors, officers, managers, employees, agents, representatives, and affiliates, and their respective successors and assigns, heirs, executors, and administrators (collectively, "EABOR") in consideration of participation in activities described on registration forms completed for Participant and additional activities or events ("Activities"), which may include, but are not limited to, related to volunteering, outdoor and water-related activities, domestic animals or wildlife, cooking, lifting items, fundraisers, and construction (e.g. Habitat for Humanity projects). Releasor understands and freely chooses to incur the scope, nature, and extent of the risks and inherent dangers involved with the Activities. EABOR does not assume any responsibility for Participant, including, but not limited to medical care or insurance. Releasor agrees never to institute any suit or action against EABOR nor to initiate or assist in the same, and exempts and releases EABOR from any and all liability, claims, demands or actions or causes of action whatsoever, arising out of any damage, loss or injury to Participant (including without limitation bodily injury, personal injury, illness, or death) or Participant's property while participating in the Activities or related or incidental events or activities, whether such loss, damage or injury results from EABOR's negligence or other cause. Releasor will indemnify and hold harmless EABOR from any and all losses, claims, actions or proceedings of every kind and character presented or initiated by any third party and which arise directly or indirectly from the Activities or related or incidental events or activities. Releasor agrees that this Release shall continue in full force and effect in the future at all times during which Participant participates in any Activities or otherwise interacts or enters into arrangements with EABOR, and shall be binding upon Participant's heirs, executors, and administrators. Releasor does hereby grant and convey unto EABOR all rights, title, and interest in any and all photographic images or video or audio recordings which contain the image, likeness, or voice of Participant involving the Activities. Releasor shall not rely on any representations other than written herein. This Release shall be governed by Florida law. If any clause shall be held to be invalid, it shall be severable.

NOTICE TO THE MINOR CHILD'S NATURAL GUARDIAN

READ THIS FORM COMPLETELY AND CAREFULLY. YOU ARE AGREEING TO LET YOUR MINOR CHILD ENGAGE IN A POTENTIALLY DANGEROUS ACTIVITY. YOU ARE AGREEING THAT, EVEN IF EABOR USES REASONABLE CARE IN PROVIDING THIS ACTIVITY, THERE IS A CHANCE YOUR CHILD MAY BE SERIOUSLY INJURED OR KILLED BY PARTICIPATING IN THIS ACTIVITY BECAUSE THERE ARE CERTAIN DANGERS INHERENT IN THE ACTIVITY WHICH CANNOT BE AVOIDED OR ELIMINATED. BY SIGNING THIS FORM YOU ARE GIVING UP YOUR CHILD'S RIGHT AND YOUR RIGHT TO RECOVER FROM EABOR IN A LAWSUIT FOR ANY PERSONAL INJURY, INCLUDING DEATH, TO YOUR CHILD OR ANY PROPERTY DAMAGE THAT RESULTS FROM THE RISKS THAT ARE A NATURAL PART OF THIS ACTIVITY. YOU HAVE THE RIGHT TO REFUSE TO SIGN THIS FORM, AND EABOR HAS THE RIGHT TO REFUSE TO LET YOUR CHILD PARTICIPATE IF YOU DO NOT SIGN THIS FORM.
