December 13, 2015

Meeting called to order by President Jay Pagano at 10:43 am in Pagano's apartment, 113 West 18th St, New York, NY.

Jim Vandernoth motioned to approve the November board meeting minutes. Nicole LaFountaine seconded and the motion carried.

Presidents Report

FIMI

- There is a monthly call between the communities and the government agencies.
 - The real estate phase for the communities, including easements, is estimated to be complete by September 2016.
 - o Contract number 1 covers Smith Point
 - o Contract number 2 covers the Lighthouse and Fair Harbor
 - o Contract number 3 covers Ocean Beach to Davis Park; 3 may be subdivided.
 - o No sand has been put in front of any community as of yet but it is expected any day.
 - Once sand is placed in front of one community it has to be placed in front of all.
 - o We have photos of dredging equipment already on the beach.
 - o Dune crossovers for beach access are a big issue.
 - There will be three disability crossovers in the Pines.
 - One at Atlantic Walk and two at either end of the community.
 - o There is concern about the cut at Coast Guard Walk.
 - The Army Corps views the cut as a potential breach and would prefer it be located at the end of the community.

Trap Bags

- The Trap Bag project has been delayed.
 - o The Town received two bids on the project.
 - o The requsite number of bids were not received.
 - o FIPPOA is still aiming to get the project underway in January.

Dolphins

- There has been an administrative hang up and the legal department wants the language for the dolphin replacement RFP to be reworded.
- o The bids came in high and FIPPOA is moving to resolve it.

Fire Island Boulevard

- The Town started a project to sell the greenway along the boulevard from Crown to Fisherman.
 - This issue was raised by Chris Taylor at a fundraiser for Town Supervisor Ed Romaine last year.
 - o The properties are listed for sale from \$20,000 to \$60,000.
 - This project was started by the Town without FIPPOA's input.
 - o Town Supervisor Ed Romaine has put the project on hold because of FIPPOA's concern.

Finance

Henry Robin, Treasurer, reported:

- 2015 has not been officially closed, but looks like it will come in at break even.
- The draft 2016 budget was circulated by email to the Board and reflects a profit of \$23,567.
 - o Harbor and Membership income are flat for 2016.
 - o AT&T cell phone towers are not in the budget as they are not expected to be installed in 2016.
 - User group contributions for the use of Whyte Hall have been reduced as FIPAP plans on replacing equipment as opposed to donating all cash.
 - o FIPPOA's two major expenses (personnel and insurance) increase annually.
 - D&O insurance increased due to the Roncalli Lawsuit against FIPPOA.
 - There was a brief discussion about self-insuring because of the large Brockman endowment.
 - o Will investigate further with Roger Kluge for further discussion.
 - o In the last couple of years FIPPOA has spent more than it brought in and would have operated in the red, but for additional income.
 - The 2013 60th Anniversary Party and the 2015 Pines Party made up the deficits in those years.
 - As per the Endowment Task Force up to 4% of the average principal balance of the Brockman Endowment will be available to FIPPOA Charitable Foundation.
 - Reserve accounts will be started for Whyte Hall and FIPPOA.
 - The 2016 budget includes \$7,000 for the Whyte Hall physical audit as well.
 - o FIPPOA pays Tony's Barge for weekend cleanups in the summer.
 - FIPPOA approached the Pines Chamber of Commerce to take on this expense but received no reply.

Robin motioned to approve the 2016 budget. Tad Paul seconded and the motion carried.
