PORTFOLIO MANAGER'S COMMENTARY

Markets continued higher this week, despite the terror attacks in Paris. A similar reaction was seen after the Madrid and London attacks that took place in 2004 and 2005, respectively. These types of attacks have not caused meaningful impacts to markets, historically. Defense companies, such as Raytheon, saw their shares prices rise in response to the increasing threats.

After yesterday's Federal Reserve minutes, markets continued higher. Expectations for a rate hike in December have strengthened, and that helped to dissipate some of the lasting uncertainty in financial markets. According to a statement from the FOMC's October meeting, "It may well become appropriate to initiate the normalization process at the next meeting."
