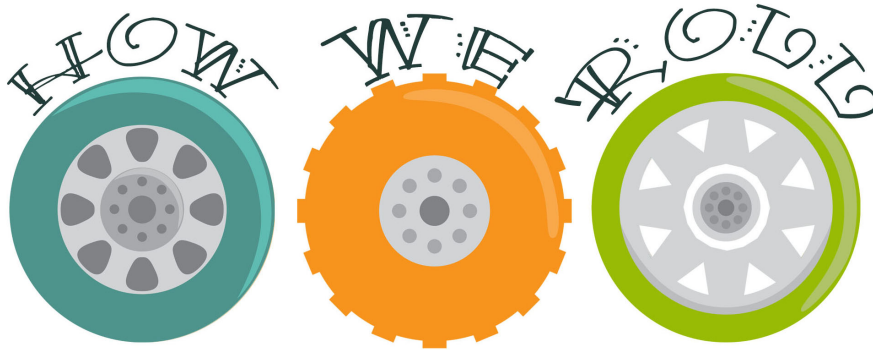

VECHILE COMMITMENTS FOR THE 1st ANNUAL

How We Roll: A Touch a Truck Event

By signing this form below, you are agreeing to all the terms of the **How We Roll: A Touch a Truck Fundraising event**.

YOU AGREE TO THE FOLLOWING:

1. Vehicles must be on premises between 8 and 9 am the day of event. Vehicles requiring a large turning radius should arrive no later than 8.
2. Vehicles must not leave premises before **1:15 pm** the day of the event.
3. Vehicles must be moved no later than 3 pm the day of the event.
4. The owner/operator of the vehicle must remain with the vehicle at all times during the event. You are encouraged to send a minimum of 2 people.
5. A completed vehicle commitment form and picture of vehicle must be submitted by **June 10, 2016**.
6. Owners/Operators are encouraged to giveaway things that are appropriate for children. (Stickers or other small giveaways)
7. Owners/operators grant permission to Families Helping Families to take photographs or record videos for the purpose of promotion and publicity.
8. Owners/operators are allowed to bring a pop up tent. **How We Roll** will not provide any tents.

WHAT WE NEED:

1. Unique/Rare/Novelty (Limos, monster trucks, antique trucks)
2. Construction (Cement & dump trucks, center rollers, etc.)
3. Emergency (Ambulances, police cars, fire trucks & equipment)
4. Farm Equipment (Big tractors, plows, etc.)
5. Commerical (Postal, delivery, 18-Wheelers, etc.)
6. Military (All types)
7. Recreational (4-wheelers, motorcycles, campers, etc.)
