



## Santa Clara County CARES Plus Fact Sheet 2015-2016

#### **Overview**

The Santa Clara CARES Plus Program (Comprehensive Approaches to Raising Educational Standards) provides financial awards to early educators based on their educational achievement and the completion of professional development activities. These financial stipends have proven to be significant incentives to early educators towards furthering their education and enhancing their professional development.

Santa Clara CARES Plus is funded by First 5 California, FIRST 5 Santa Clara County, and the California Department of Education, and is operated by the WestEd E3 Institute.

## **CARES Plus Benefits Participants**

- Financial incentives to support individual's professional development goals
- One-on-one advising for professional development planning
- High quality training through multiple delivery methods
- Training materials and online courses
- A unique opportunity for individualized one-on-one video coaching
- Support in earning an Associate's, Bachelor's or Master's degree
- Support for the translation and evaluation of international transcripts and/or degrees for their U.S. equivalencies
- Opportunities to complete professional development requirements and college units to earn and maintain a California Child Development Permit

#### **CARES Plus Activities**

Cares Plus has a variety of professional development activities that early educators can complete to earn a stipend each program year. First time participants must complete a series of required online activities when they enter the program. There are also optional activities participants may choose from to increase their stipend amount if they are interested in completing additional coursework or training. If a participant completes the annual requirements he/she may also be eligible for additional incentives that will be added to the total annual stipend amount.

## **Required Activities**

### CARES Plus CORE Requirements are required for first year participants.

Three online activities must be completed during the program year to receive a core component stipend. CARES Plus introduces program participants to The Classroom Assessment Scoring System™ (CLASS™), an observational tool that provides a common lens and language focused on the classroom interactions that boost student learning. CARES Plus participants will complete two online activities to learn about this tool.
