INSTRUCTIONS:

- Entries must be ready for display.
- Works to be hung on the wall must have a secure wire hanger: NO SAWTOOTH hangers will be permitted.
- Unusual hanging mechanisms must be approved by the Visual Arts Coordinator.
- All quilts must have Velcro on the back for wall hanging. Large Quilts and other fiber large pieces must have 2 inches of Velcro stitched along the entire top. NO VELCRO, NO ACCEPTANCE.
