

SHOULD OBAMA BE IMPEACHED?

Survey after survey and comment after comment from politicians and political figures indicate that the Obama Regime is the most impeachable administration in U.S. history. Numerous members of Congress have stated that they believe Obama should be impeached and even legal experts like Judge Andrew Napolitano have stated that Impeachment is the only constitutional solution we have in America at this point. A vast majority agree that Obama has committed impeachable offenses and that he deserves to be impeached.

CAN OBAMA BE IMPEACHED?

As of January 2015, Republicans now control both chambers of Congress. Republicans alone have the votes to pass Articles of Impeachment out of the House Judiciary Committee and the House of Representatives. Obama CAN be impeached by the House of Representatives without a single Democrat vote. The moment the House sends Articles of Impeachment to the Senate for trial, Obama has been impeached, he has been indicted, and everything he has done in his administration will be put on trial.

WILL THE SENATE CONVICT?

In an impeachment, the U.S. Senate acts as a jury, not a legislative body. The rules are very similar to that of any other criminal trial. In the case of impeachment of a president and/or vice president, the Chief Justice of the Supreme Court will preside.
