Recognize the subtle game of cat and mouse and help us dig a little deeper.
Force the viewer to look around the corners and reward us for our efforts!**

ELIGIBILITY

- Work must be original.
- Work must not have been exhibited previously at FLAC.
- All work must be priced for sale or NFS (not for sale).
- All work must remain in the exhibition until the closing date unless purchased.

CONDITIONS

- Wall pieces may not exceed 48" in any dimension.
- Wall pieces may not weigh more than 50 lbs.
- Work must be gallery ready and properly equipped for hanging from display equipment or for free-standing installation.
- Multi-unit works or pieces with specific installation requirements must be accompanied by detailed assembly instructions when delivered for exhibition.

SALES

- Work for sale must include price.
- Fuller Lodge Art Center takes a 35% commission on all works that are sold. Price on entry form must include commission.
- Insurance value is 65% of sale price. We can only insure up to \$1000. Artists wishing more insurance must provide their own.
- Sold items remain on display unless a sale is contingent upon immediate release, in which case the buyer will be allowed to take the artwork at the time of purchase.

LIABILITY

Reasonable precautions will be taken to protect work while at Fuller Lodge Art Center. Accepted work will be insured while in custody of FLAC, subject to the Artist Consignment contract which will be sent upon acceptance. Fuller Lodge Art Center cannot accept responsibility for loss or damage to work while in transit to or from the Art Center.

ENTRY PROCEDURE

- Complete the entry form.
- Submit a non-refundable entry fee of \$15 for one piece; also include a non-refundable \$5 fee for each additional piece submitted.
- Submit one image of each piece entered. For 3-D work, two images may be submitted.
- **Make check payable to: Art Center.**
- *Note: Fuller Lodge Art Center reserves the right to all images for promotional purposes, with credit given to the artist.*

SUBMISSION MEDIA

- Submit photos that are in focus and of good quality.
- Digital images on CD are the preferred format. These should be in JPG format at a minimum of 5x7inch, 300 ppi resolution. No "thumbnails" please. Call Nancy if you have questions.
- Photos may be submitted by email in JPG format to: **gallery@fullerlodgeartcenter.com.**
- Label images with artist last name and title: **ArtistTitle.jpg**
- The juror(s) reserve the right to reject images of poor quality, those that do not include the required information, or for any other reason.
- Accepted work that is submitted in a digital format will be included in a virtual gallery on our website. This slideshow may remain on the site indefinitely after the show. (Printed images and slides will not be included on the website.)
