Unit Business Meeting at the Thanksgiving & Installation Rally

WBCCI Northern Illinois Unit Business Meeting Minutes October 17, 2015

President David Mayo called the meeting to order at 10:30 a.m. at the Lee County Fairgrounds in Amboy, Illinois. He led the unit in the Pledge of Allegiance to the flag. Roll call found all officers and trustees present. A quorum was present and a valid meeting could be held.

The minutes of the April 18, 2015 meeting were read and approved.

President Mayo utilized a "Power Point" presentation using a laptop and the unit projector in conducting the meeting.

The unit financial report was presented and reviewed in detail. It was noted that prior to today, the unit checkbook has a balance of approximately \$1,782. President Mayo said that Unit Rallies are to be self-funded and that the excess dollar amount of the 2015 rally fees over rally expenses is \$68. This is due to rounding up rally fee amounts so that coin change isn't required at the rallies. This excess will be used to purchase rally related items such as propane for the club grill that will be used at unit rallies in 2016.

President Mayo mentioned that Carol & Dwight Dixon are planning to attend the 2016 International Rally in Lewisburg, West Virginia. The Dixons mentioned that members should also consider the Taste of Blue Ridge caravan as it ends near Lewisburg around the rally time.

The Northern Illinois Unit Barbeque Grill



This grill has a long history with our unit as I was informed by our member Dwight Dixon, he said many a hamburger was cooked on it. He was able to purchase it for the Unit many years ago. On the left are grills, for those hamburgers and the right side has about a 6 inch burner, both sides are fed by a ten pound propane tank.



Also two grill plates are available, for either side, for us at the same time or just one side.



What is really nice the grill legs fold up under the grill and all the loose parts fit in carrying bags. I will have this grill in the back of my truck at the camping rallies and the Camping Host is welcome to use it and any member. After applying one and a half cans of oven cleaner and two high pressure power washes and baking the gills with a coating of vegetable oil, the grill is ready to cook some more hamburgers. Oh, and Marge washed the carrying bags.

Tech Time

Hello to the members of the NIU. Sandy and I hope you all enjoyed your Christmas and that we all have a very Happy and Healthy New Year. We feel very fortunate, as we have had quite a few opportunities in 2015 to get out and do some Airstreaming and we are really looking forward to the 2016 season. I can't wait for winter to be over.

I know we have all heard how important proper tire care is on our rigs and tow vehicles. A blow out on an Airstream can cause significant damage, in addition to the inconvenience and the safety concerns, with trying to change a tire on the side of the highway. I mention this, as this summer, on a trip back from Branson MO., we were traveling with some friends who were towing a large boat behind a Chevy Diesel pick up. Traffic was very heavy and the temperature was in the upper 90's. The boat trailer has tandem axles and one of the tires on the street side blew out. The spare was located only to find that it was very low on air. Fortunately, another couple was driving a motor home with an onboard compressor and the

tire was properly inflated. Problem fixed and not a big deal but if this was an Airstream trailer, it certainly could have been an expensive situation, with the damage to the aluminum that could occur with a blow out.

Moral of the story? Check your tire pressure daily when traveling. Check the date code on the tires and consider replacing them if they are more than 5 years old. Also, pick up an infrared temperature tester. These things are great to quickly check the tire and wheel temperature when making a pit stop. A high comparative temperature reading could indicate an under inflated tire, or perhaps a bearing issue. There are also after market tire pressure monitoring systems out there that work very well and provide real time data of your tire pressure and temperature.

Keep safe, keep warm, hope to see you soon and let's wear em out!
