# Quilt Entry Criteria and Rules

**Definition/Size of a Quilt for our show:** A quilt is two layers of fabric with a filling or batting that is stitched together. Quilting may be done by hand or by machine. Quilts must be a minimum of 24" x 24". Quilts should be clean and ready to be presented. Warrenton Quilt Days reserves the right to refuse any entry that may be deemed unsuitable for show display. Considerations may include fragility, quilts in need of repair, and unusual shapes that are difficult to hang.

**Quilt Entry/ Fees:** The quilt entry fee for the general show is \$5 per quilt. The entry fee for Viewer's Choice quilts is \$10 per quilt. Each exhibitor may enter a maximum of 5 quilts of which 3 can be Viewer's Choice. We encourage you to submit your quilt entry electronically on our website [www.warrentonquiltdays.com](http://www.warrentonquiltdays.com). An original registration form is required for each entry. Information from the registration form will serve as the show exhibit tag for the quilt while it is on display and must be completed entirely. The entry description section is for interesting information or details about your entry. Please limit your description to a maximum of 75 words.

Paper forms can be requested for quilt entry. Paper copies of entry forms are available for mailing or pick up at Quilt Lizzy, 110 E. Macon Street, Warrenton, NC or the Quilt Lizzy Training Center at 115 E. Market Street, Warrenton, NC. There will be a \$2.50 handling fee for mailing paper copies of registration forms. Please call 252-257-7117 to request paper copies of entry forms. Requesting entry forms does not reserve a space for your quilt(s) in the show. Forms may be returned to

The deadline for registering quilts is **March 31, 2016**. Quilt registrations are accepted on a first come, first serve basis until the show is filled. You will receive email confirmation for entries submitted on the website. Confirmation for paper entries will be mailed through the U.S. Postal Service.

**Label/Photo:** A label must be sewn to the back of each quilt with the quilt name, exhibitor's name, address and phone number. The quilt name and exhibitor's name on the label must match the information on your registration form. When shipping or dropping off your quilt, please include a photo (4"x 6" maximum) of each quilt. The photo must include the whole quilt.

**Photography:** Quilt entries may be photographed by Warrenton Quilt Days, Preservation Warrenton, show attendees, and the media. Submission of an entry to Warrenton Quilt Days constitutes consent by the entry owner to allow it to be photographed.

**UPC Code:** A UPC code will be issued when entries are dropped off, or kept on file for entries that are shipped. The UPC code will be required to pick up entries following the quilt show. Identification may also be required to pick up entries. No entry will be released without the UPC code.

**Quilt Delivery and Pick-up:** Prior to the show, quilts may be delivered to the Quilt Lizzy Showroom and Training Center during normal business hours **Tuesday, March 15 through Tuesday, April 5**. If your quilt is not received by **April 5**, we cannot guarantee it will be hung in the show. See address and business hour below:

After the show, quilts may be picked up at the Quilt Lizzy Showroom and Training Center during normal business hours beginning Tuesday, April 19 through Friday, April 23. Quilts will not be available for pick up on show days. Any quilts left at the center after April 23, 2016 will be donated to charity.

**Shipping:** Quilts may be shipped to arrive **March 15 through April 5, 2016.**

**Return Shipping:** We will gladly ship your quilt back to you. Return shipping must be pre-paid at the time of quilt entry. Quilts will be shipped by April 29 via U.S. Postal Service Priority Mail. Please provide the following information for return shipment:

- Shipping and handling fee of \$15.95 per quilt (paid at time of quilt entry)
- Name
- Street address or P.O. Box, city, state and zip code
- Telephone number

Optional insurance is available for an additional fee and can be added when checking out.
