OUR 9-DAY/7-NIGHT TUSCANY AND ROME TOUR ITINERARY:

DAY 1 - BOSTON~INTERMEDIATE CITY~ITALY: Depart Boston's Logan International Airport on our transatlantic flight to Italy (via intermediate city) with full meal and beverage service, as well as stereo headsets, while in flight.

DAY 2 - MONTECATINI: Upon arrival in Italy, we will meet our Tour Escort and transfer to the first-class Hotel Montebello (or similar) in Montecatini. We will enjoy lunch at the hotel and then an afternoon at leisure to explore our new surroundings. Dinner and overnight. (L, D) Hotel website: http://www.hotelmontebello.it

DAY 3 - FLORENCE: After breakfast, we depart by private motorcoach with an English-speaking escort for Florence. On our tour, we will walk around the stirring sights of Florence, including Giotto's Bell Tower, Ghiberti's Gates of Paradise, and Brunelleschi's Dome, The tour ends in Signoria Square. We will have time for lunch (on our own) and then visit the Academia, home to Michelangelo's David. The rest of the afternoon is at leisure, for further exploration. Check out the famed Ponte Vecchio Bridge or the Medici Palace. Return to Montecatini for dinner at our hotel. Dinner and overnight. (B, D)

DAY 4 - SIENA: After breakfast, we will drive southwest through the heart of Italian wine country, over the rolling hills of Chianti to Siena. Once in Siena, our escort will lead us to Piazza del Campo, through the narrow streets, past medieval towers and walls. One of the notable highlights of Siena is San Domenico, which holds relics of St. Catherine. En route, we will visit San Gimignano, often described as "the most famous small town in Italy." This charming medieval hilltop town is noted for its many towers and breathtaking views of the Tuscan landscape. We'll return to Montecatini for dinner and overnight. (B, D)

DAY 5 - VENICE: After breakfast, we depart for Venice. We will board a vaporetto to San Marco Square where a local guide will be waiting to show us around this unique city, "the Queen of the Adriatic." Visit St. Mark's Basilica (entrance included), walk over small bridges to the Bridge of Sighs and past winding waterways to the Rialto. Following our sightseeing tour, we will have lunch (on our own). The remainder of the afternoon is free for shopping, visiting the local sites or taking a gondola ride. Return to our hotel for dinner and overnight. (B, D)

DAY 6 - MONTECATINI~ASSISI~ROME: After breakfast and hotel check-out, we will head to Rome, with a stop in Assisi, for some guided sightseeing. We will visit the Basilica of St. Clare (dedicated to the founder of the "Poor Clares" order) which was erected in 1265 and contains the incorrupt body of the saint as well as the Piazza del Comune with its ancient Roman temple. We will also see the Basilica of St. Francis, with Giotto's frescoes and Cimabue's painting of the Crucifixion and the tomb of St. Francis. After our visit, we drive down the hill to Santa Maria degli Angeli, where we will see the Basilica where St Francis spent most of his life. Then we will continue on to Rome, for check-in at our first-class hotel, the Hotel Medici (or similar). Dinner will be at a local restaurant and overnight at our hotel. DAY 7 – VATICAN CITY: After breakfast, we will visit St. Peter's Basilica, the Vatican Museums, and the Sistine Chapel. Raise your eyes to see Michelangelo's "Creation" and the famous "Last Judgment." After lunch (on our own), we'll have the afternoon at leisure for shopping and browsing or exploring on our own. Dinner and overnight. (B, D)

DAY 8 – ANCIENT & MODERN ROME: After breakfast, we will enjoy a full day of sightseeing. In the morning, we will have our Ancient Rome tour, featuring the famous monuments and landmarks of Rome. In the afternoon, following time for lunch *(on our own)*, we will meet up for a tour of Modern Rome. By the time our day winds to a close, we will have seen the Colosseum (outside only), the Pantheon, the Spanish Steps, Trevi Fountain, and so much more! Return to our hotel for dinner and overnight. (B, D)

DAY 9 – ROME~INTERMEDIATE CITY~BOSTON: After breakfast and hotel check-out, we'll transfer to Fiumicino Airport in Rome where we will board our return flight to Boston, with full meal and beverage service, as well as stereo headsets, while in flight. (B)
