ABOUT THE KEY CLUBHOUSE OF SOUTH FLORIDA



Serious mental illnesses such as schizophrenia, bipolar disorder and major depression, strike 1 in 17 people, usually in the prime of their youth, regardless of gender, ethnic background or economic level. The results can be devastating.

It takes tremendous courage, persistence and hope to learn how to overcome the mental and physical changes that come with mental illness. The Key Clubhouse is there to help.

The Key Clubhouse of South Florida was founded in 2010 by a grassroots group of family members and consumers to help adults

living with serious mental illness rebuild their lives. The Clubhouse follows the evidence-based International Clubhouse model operated in 33 countries around the world

The Clubhouse provides an accepting place to spend the day, participate in valuable work that supports Clubhouse operations, socialize with friends and co-workers and gain access to employment within the community. Membership is for life and provides ongoing support.

Open five days a week and on major holidays, the Clubhouse offers the following:

- The "work-ordered day," an eight-hour period, five days a week, during which members and staff work side-by-side on an equal basis to carry out the tasks involved in running the Clubhouse
- Employment opportunities for members to return to paid employment
- Assistance with continuing education
- Support and referrals for affordable housing, mental health care and other services
- Low-cost, nutritional breakfasts and lunches
- Wellness and fitness activities
- Reach-out, such as telephone calls or visits when a member does not attend the Clubhouse.

OUR MISSION

Our mission is to afford people whose lives have been disrupted by mental illness the opportunity to recover meaningful and productive lives through reintegration in the workplace and the community. Our goal is a high quality of life for all members, ongoing improvement, and the ultimate elimination of stigma associated with mental illness.

WHY YOUR SUPPORT IS CRITICAL

We depend on charitable donations from the community to keep our doors open. We are the only mental health rehabilitation program in Miami-Dade County that is free and open to any adult with a serious mental illness, whether or not they are covered by insurance. 

Key Clubhouse Expenses


