There are no curb cuts for disability access and stroller access at the intersection and cars back up on 16th Ave SW when heading south and attempting to turn left onto SW Holden St. at the light.

Cars coming from SW Holden St heading south to 16th Ave SW get backed up on SW Holden at the light when trying to turn left onto 16th Ave SW. This causes increase in driver frustration which leads to speeding and an increase in accidents at the intersection.

- 1) Modernizing the signal and building accessible curb ramps at this intersection; 2) Create left turn lanes and signals at 16th SW onto SW Holden in both directions and coming south on SW Holden onto 16th SW heading south add left turn lane and signal at the light.
