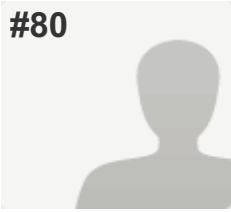

Delridge Wetlands Street Improvement Project

The closest intersection is 23rd Avenue SW and SW Findlay Street.

Q3: What is the problem(s) at this location that you'd like this project to fix? Please give as much detail as you can by describing what you experience at this location.

The newly developed wetland sits on the site of the former Seattle City Light Transfer station, and with the investment in restoring the wetland, augmenting the natural habitat and introducing urban agriculture here, there needs to be a safe way to walk to the site by the youth who will be accessing it. The surplus property is being transformed into a learning landscape for the children at K-8 STEM at Louisa Boren School and a learning and physical fitness site for the Children's Academy located on the corner of Delridge Way SW and SW Juneau.

Q4: If you already have a particular solution to the problem, please describe it here. (Please note that SDOT staff often need to modify proposed solutions during design development to meet regulations or to adapt to site conditions.)

We need to have sidewalks installed along Juneau and along 23rd SW so that classrooms of children do not have to walk in the middle of the street to access the site.
