What is a Research Report?

The International Building Code (IBC) defines a research report as a publication from an approved source where supporting data is evaluated to assist in the approval of materials or assemblies not specifically provided for in the code. PFS RR helps building code officials decide whether or not a product, material, or method of construction can be approved for use under the "alternative materials, design and methods of construction" provisions of the applicable code(s).

Where can I find the program details?

The PFS RR service—which is fully explained in PFS 1601, *Requirements Covering Research Reports*—provides our requirements for PFS RR within the framework of nationally recognized codes and standards. In it, we define the sequence of events and actions that must take place from the time the applicant contacts PFS TECO to the time the PFS RR is reviewed, accepted, and published on the PFS TECO website. What qualifies PFS TECO to provide these services?

The IBC requires that approved agencies shall "be objective, competent, and independent," have "adequate equipment to perform required tests," and "employ experienced personnel." PFS TECO delivers on all three counts with approvals to provide inspection, testing, and certification services in accordance with the following internationally recognized standards:

- ISO/IEC 17020, Requirements for the operation of various types of bodies performing inspection
- ISO/IEC 17025, General requirements for the competence of testing and calibration laboratories
- ISO/IEC 17065, Requirements for bodies certifying products, processes and services

Does PFS TECO have expertise in the evaluation and listing of construction products and systems?

What are certification marks?

Certification marks, like the PFS checkmarks and the TECO TESTED® mark shown here, are used to certify the performance and/or quality of a product, material, or assembly.

PFS TECO maintains registered certification marks which are recognized in the United States and/or Canada. When building officials and consumers see a PFS TECO certification mark on a product, material or assembly, this is evidence that PFS TECO has successfully evaluated a representative sample of the product, material or assembly for conformance to published standards, and that the manufacture of the product, material or assembly is under periodic audit/inspection by PFS TECO.
