- Finalist must have a representative on site to receive the award if selected.

- Presents job information in a clear, concise manner
- Maintains a clean, safe jobsite
- Maintains good subcontractor relations
- Community involvement
- Promotes safety on the job
- Presents clear and complete pay app procedures
- Solicits value engineering from subcontractors and supplies
- Participates and supports professional construction organizations

### Subcontractor of the Year

This award recognizes the best Sub-Contractor. One award for each of the following subcontractor categories:

- Revenue Under \$2 Million
- Revenue \$2 Million to \$7 Million
- Revenue Over \$7 Million

Criteria to consider:

- Strong diversity inclusion program-Supports diversity on the job
- Sends submittals in a timely manner
- Arrives with fully equipped crew ready to work
- Displays a "can do" attitude when the unexpected roadblocks arise
- Pays second tier subcontractors and material suppliers on time
