

# Minutes of the Eighty-second Annual General Meeting of The Canadian Institute of Plumbing & Heating L'Institut canadien de plomberie et de chauffage

Held at Delta Grand Okanagan, Kelowna BC Tuesday, June 24th, 2014, 9:30 a.m.

Chairman: R. Whitty

#### 1. & 2. WELCOME AND QUORUM

Chairman of the Board, R. Whitty (Bartle & Gibson) called the meeting to order at 9:30 a.m. President R. Suppa confirmed that A QUORUM WAS PRESENT.

#### 3. CHAIRMAN'S REMARKS

Chairman Whitty thanked the voting delegates and guests for attending. Voting delegates present represented 31 Manufacturers, 12 Wholesalers, 4 representing the Manufacturers Agents' Council and 7 representing Master Distributors for a total of 54. Thirty-nine (39) proxies had been received for a total of 93 votes of the 154 total. Delegates from 63 member companies and 4 subsidiaries were present.

## 4. MINUTES OF THE 2013 ANNUAL GENERAL MEETING

It was moved by Bill Palamar, seconded by Allen Taylor and carried:

"The Minutes of the 2013 Annual General Meeting be approved as circulated."

#### **5. BUSINESS ARISING FROM THE MINUTES**

The CIPH Bylaw changes and the new articles of continuance as per Canada's Not for Profit Corporations Act had been sent out and approved by the Minister of Industry.

#### 6. ANNUAL REPORT

Chairman Whitty, with the assistance of President Suppa, made a brief Annual Report to the members. There were no questions.

#### 7. REPORT OF THE TREASURER

J. Hammill (Moen Canada) presented the 2013/2014 Audited Financial Statements. (The statements were distributed via e-mail to each Member Company prior to the AGM).

The 2013/2014 audit showed a modest deficit in revenue from the previous year because of the two year trade show revenue cycle. The major trade show revenue usually falls in even numbered years. This year's net trade show revenue totalled \$356,801 versus \$708,840 the previous year.

The 2013/2014 budget called for a deficit of \$340,000. Because of the accrued surplus from over 40 years of trade shows, CIPH can handle the deficit years without cutting programs.

Total revenues were up 1.9% because investments performed better than expected.

GST, EI, CPP and payroll taxes were handled professionally. The auditors found the CIPH books in excellent shape.

For 2014/2015 the Board has budgeted for a modest deficit of \$161,000. CIPH now have unrestricted net assets of \$2.8 million which are invested in quality conservative investments which are managed by a third party, Kerr Financial.

Based on member feedback and input as part of the recent Long Range Plan, the CIPH Board has invested in the following key activities to benefit members in 2014/15:

- a) \$81,000 to continue to hire a PR/Communications firms specifically directed to help CIPH with recruitment and increasing awareness of career opportunities in plumbing and heating;
- b) \$25,000 allocated as scholarships for 10 Technical Institutes or \$2,500 each;
- c) \$25,000 allocated to help the smaller CIPH regions to hire business speakers in an effort to help build attendance:
- d) \$25,000 allocated to hold an Annual Summit Meeting of the CIPH regions;
- e) \$130,000 to house and operate activities of the Canadian Hydronics Council
- f) \$25,000 to continue to produce an economic and industry trends newsletter by the Altus Group on a quarterly basis on a quarterly basis with a focus on the Canadian economy, housing and construction sector along with leading economic indicators; and
- g) Funds are also allocated for a "technical advisor" to assist with codes and standards and the addition of one new CIPH staff for the role of Manager of Operations.

## 8. APPROVAL OF ANNUAL REPORT, FINANCIAL STATEMENTS AND ACTIONS OF OFFICERS AND DIRECTORS (MOTION #1)

It was moved by Paul McDonald, seconded by Martin Deschenes and carried that:

Approves the 2013/2014 Annual Report and the Audited Financial Statements and instructs Messrs. Robert Whitty and John Hammill to sign the Audited Financial Statement. And does ratify, confirm and approve all acts of the Directors and Officers of the Canadian Institute of Plumbing & Heating as outlined in the Annual Report since the last Annual General Meeting thereof June 18, 2013.

There was no discussion.
