Prior to joining the Atlanta Fed, Andreason was a research associate at the Penn Institute for Urban Research at the University of Pennsylvania (PennIUR). There, he helped develop a set of indicators of livable and sustainable communities for the U.S. Department of Housing and Urban Development funded by the Ford Foundation.

Jen Bennecke is the President of Jensen Strategic Partners, a community and public affairs consulting firm. She is the immediate past president of the Junior League of Atlanta (2014-2015), and in 2014 was recognized as "Philanthropic Leader of Tomorrow" by the Greater Atlanta Chapter of the Association of Fundraising Professionals. Bennecke is a dedicated community leader and diligent volunteer, sitting on various nonprofit boards including the Atlanta Children's Shelter, Foster Care Support Foundation as well as the Community Foundation for Greater Atlanta Community Partnership Committee. She also founded a task force that became the nation's first statewide collaborative to address the commercial exploitation of children; through her philanthropic efforts she has raised

Helen N. Parker is a nationally recognized consultant in workforce development. She provided leadership and direction to the workforce system in the states of Alabama, Florida, Georgia, Kentucky, Mississippi, North Carolina, South Carolina and Tennessee. Prior to her federal service, she spent almost 28 years with the Georgia Department of Labor.
