Seven (8) Voting Seats Open on the OAA Board of Directors

<u>Duties of the Board</u>: Shall have supervision, control and direction of the affairs of the Association within the limits of and consistent with the beliefs and policies and resolutions promulgated by the Delegate Assembly and the Constitution and Bylaws. The Board of Directors shall actively promote the purposes of the Association, shall set all dues, assessments, and charges, shall adopt the Association's budget, and shall have discretion in the disbursement of the Association's funds.

Board Composition: The Board of Directors shall be composed of the four elected officers, the Immediate Past President, Guild Council Chairman and eight Directors. The eight elected Directors shall be composed of two Firm Members, two Honored Fellows representing Individual Membership, two Members from State Society Membership, two At-Large Members, who also must be a Firm Member, or Honored Fellow and a have been a voting member of the Association for a minimum of one year and one Student/Apprentice appointed by the OAA Board of Directors.

<u>President</u>: It shall be the duty of the President to preside at all meetings of the Association and to perform all duties incident to the Office of President and such other duties as may be prescribed from time to time by the Board of Directors.

<u>First Vice President</u>: It shall be the duty of the First Vice President to perform the duties of the President in his/her absence or in the event of his/her inability or refusal to act. The First Vice President, when thus acting, shall have the powers of and be subject to all restrictions placed upon the President. The First Vice President shall perform such other duties as from time to time may be assigned to him by the President or the Board of Directors.

<u>Second Vice President</u>: The Second Vice President shall perform such duties as may be assigned from time to time by the President or Board of Directors.

Secretary/Treasurer: Shall have charge and custody of, and be responsible for all funds and securities and financial records of the Association; shall keep the minutes of the meetings of the Association and the Board of Directors; shall see that all notices are given in accordance with the provisions of the Constitution and Bylaws or as required by law; shall be custodian of the corporate records and of the seal of the Association; and, in general, shall perform all duties incident to the Office of Secretary/ Treasurer and such other duties as from time to time may be assigned to him/her by the President or the Board of Directors.
