Appendix A: The Service Economy in the Central Region of New Mexico

As the central region of New Mexico emerged from the Great Recession, the broad services industry class grew to 71.3 percent of all jobs in the region in 2013. In 2006, services accounted for 63.9 percent of all jobs. Much of the growth occurred in the healthcare and social assistance industry sector, which grew from 12.3 percent of jobs in 2007 to 16.9 percent of jobs in 2013. By comparison, the share of jobs in the goods producing class steadily declined each year from 16.7 percent in 2006 to 10.8 percent in 2013. The share of jobs in the trade, transportation, and utilities industry class declined from 19.5 percent in 2007 and 2008 to 17.9 percent in 2013.

Industry classes are groups of industry sectors as defined by the North American Industry Classification System. The classes are organized into the following three groups.

The data source for this analysis is the U.S. Census Bureau's Longitudinal Employer-Household Dynamics' (LEHD) Origin-Destination Employment Statistics (LODES) program.
