200-word program summary (addressing the criteria listed above)

Expanding Horizons is a special needs program initiated by JFSofSHW in 2015, building on previous experiences with special needs populations. The program, which received an AFJCA grant for the 2015-2016 fiscal year, enabled the hiring of a Special Needs Program Coordinator. Through this role, the program has doubled its Social Learning groups for children on the Autism Spectrum by offering two groups per week for two different age ranges, re-established a parent support component, offered a sibling support group, and initiated consultation services to area synagogue and JCC preschools. An additional component serves young adults with disabilities bringing them together for socialization and recreational opportunities. Services of the JFS Career Counselor are also available to assist these young adults ranging in age from 18-35. Building on the credibility established, the JCC has requested ongoing consultation to assist with integration and management of children with special needs into the regular pre-k classroom. It has garnered the respect of a local, state funded agency that serves the special needs population and they have requested replication of the Social Learning Group Component in an underserved county in both our and their catchment areas. They have offered to support this program with partial funding.

<u>Total program cost</u> if applicable and funding sources: \$73,885. Sources of funding: Client fees, AFJCA Grant, Blanche and Irving Laurie Foundation matching gift, Jewish Federation of Somerset, Hunterdon and Warren Counties; Nancy and Arthur Lee Special Needs Fund, third party reimbursement.
