The Town received approximately \$300,000 in federal funds from the U.S. Department of Housing and Urban Development (HUD) each year to address the goals and objectives of the Town of Barnstable Consolidated Plan for 2010 – 2014. The CAPER includes a summary and evaluation on how these funds were used in 2014 to carry out the goals and objectives in the Consolidated Plan. The public is invited to review and comment on the Draft CAPER before the Town finalizes it and submits to HUD for approval.
