IMPLEMENTING AN EFFECTIVE CORPORATE COMPLIANCE PROGRAM **David Cutri**

In August of 2015, I was asked to present on this topic at the joint ISACA/IIA national conference on Governance, Risk, and Compliance (GRC). I also gave an abbreviated version of this presentation at the September ISACA chapter meeting. While these articles discuss overall corporate compliance, the concepts are easily transferable to IT governance.

Background

I have had the good fortune to be involved in building the corporate compliance program of two Fortune 500 companies and am in the process of doing the same at the University of Toledo. When these companies embarked upon their compliance initiatives, they found a complete absence of information and experience in the design and application of a comprehensive corporate compliance program, and certainly nothing that was industry-specific. The only existing body of knowledge available dealt exclusively with the health-related activities of institutions of Guidelines for Organizations. Hopefully these articles will higher education. As these companies endeavored to establish a corporate compliance program that covered all activities within their organizations, they were faced with adapting practices from their fields, using trial and error to establish best practices in uncharted areas

During the preparation for the GRC Conference, I discovered that while many companies had begun the journey into compliance, there still were only a few comprehensive compliance programs

operational in most industries. These articles are intended to share the information learned from my experience with others who are finding it increasingly necessary to implement a corporate compliance program. This is a series of articles intended to take you step-by-step through the implementation of a comprehensive compliance program.

Why and What

These articles are intended to provide overview information on this topic and discuss why your company needs an effective compliance program and the required components of such a program. They are the foundation upon which all else is built. Your company needs an effective compliance program to avoid monetary loss, damage to reputation, and demands on executive management time. The compliance program you need should follow the requirements established by the U.S. Sentencing convince you that you need to implement an effective compliance program. Once you reach that decision, all you need to know is how to accomplish that task successfully. These articles provide you with a general road map for that journey.

The next article in this series will discuss how to start down the path of developing a corporate compliance program, appointing a "champion", building an infrastructure, and advertising the program.
