Dear Minturn Residents, Business Owners and Visitors:

Once again, the winter season is almost here. As a result, the Town of Minturn would like to provide you with the enclosed information regarding the Town of Minturn Snow Removal and Parking Plan. Our goal is to help make our snow removal process safer, more efficient, and ensure ease of access for all residents.

### **PARKING PLAN**

The Town Council, as well as, the Colorado Department of Transportation (CDOT), have approved the adopted parking plan. Our parking plan is designed to help keep our streets safe and beautiful, as well as help businesses operate smoothly. Attached you will find tables outlining the no parking ordinance as well as the time limited parking. Please note that this is effective **November 1<sup>st</sup> through April 1<sup>st</sup>** whether it is **snowing or NOT snowing**. Your vehicle may receive a citation or be towed if you are found to be in violation of the parking ordinance. If you have any concerns or question please do not hesitate to contact our offices.

### **SNOW REMOVAL**

The Town would like to remind residents that all snow removal activity is held to Town of Minturn Municipal Code. It's both the Town's responsibility and the resident's responsibility to maintain proper snow removal procedures. If someone is found to be in violation, a warning or citation may issue so please be sure to help keep your sidewalks clear for the safety of others. ### **SNOW DISPOSAL**

The Town is once again offering a location site for snow disposal. The snow disposal site will be located on Cemetery Road, past the Public Works Building and the Oldcastle facility. There will not be a fee for Minturn residents to utilize the snow disposal site for snow removal from their primary residence. To schedule a time to dispose of snow, please contact the Town.

### **COMMERCIAL DUMPING OF SNOW**

Please note that there is a \$55.00 fee that will be charged for a Tandem Truck full of snow and \$90.00 fee will be charged for an End Dump vehicle full of snow. Commercial businesses must contact the Town Clerk at the Town offices to schedule use of the snow disposal site. You may contact (970) 827-5645 Ext 1 for more information.

The Town would like to thank you for your time and cooperation in reference to the parking and snow removal process. As always, the Town staff looks forward to serving you and working with you to continue making Minturn an amazing place to live, work and play.
