- 1. Vonetta greeted us and opened by reading the Prayer of St. Francis. John Stoner reflected on the life of Dan Berigan. John said we need to celebrate lives of prophets past and present. - 5. Peace Packets have been sent out.
- 6. Peace Mugs—several have been made so that we have them for the next several years. Several names were mentioned as recipients, but several of those persons are not members of an ACC church. Jon Carlson from Forest Hills was mentioned and the administrator of Forest Hills. Brook will do a short resume' of these two persons and will decide by vote at next meeting who we may want for the mug.

- 8. Budget—We are eligible to receive \$500.00 from the ACC Budget. If not used in the current year, we lose the money. We will ask for the \$500.00. Expenses were low this year—purchasing the peace mugs and peace packet expense.
- June conference A peace conference will be held at Christopher Dock High School in June. Brook will look into cost of a bus and send information to peace advocates if there would be interest in attending.

a. Spoke about the mass incarceration in the Philadelphia area and what Kingdom

- Builders Construction is doing to rehab churches and houses.
- b. Advocacy time is running out on criminal reform. Churches should call their representative regarding justice reform
- c. MCC East Coast Pennsylvania local Native American tour October 31 November 4 hosted by Mark Charles. This is a learning tour, part of the loss of Turtle Island.
  - i. You would leave from Akron each day. Also learning about the Paxton Boys massacre in 1763. Darvin Martin will also be guiding other Indian sites, including the Paxton church.
  - ii. The tour also includes travel to Washington D.C. some of the various treaties, confession and lament
  - iii. The first day is open to anyone, but the rest of the tour is limited to 15 persons and cost is approximately 250.00.
- d. MCC Disaster Relief in Ecuador 660 died, 22,000 displaced and 8000 building destroyed.
- e. MCC—MDS is responding to the fires in Fort McMurry in Alburta, Canada to do rebuilding. Curtis will give Brooke some web sites for more information on these various activities.
- 12. Roger Martin—mentioned the proposal extended to women to register at age 18 for the military. This could possibly be required. Do we know where this is going?
