## 2016 Michigan 4-H Shooting Sports State Trainer Application

Please thoroughly read and follow application instructions. Complete all questions and provide required documents in the specified format. Application and reference letters **must be <u>emailed</u>** by 5:00 pm Friday, October 16, 2015 to be considered. Email to Nick Baumgart, MSUE 4-H Shooting Sports Educator, <u>baumga75@anrmsu.edu</u>. Questions should be directed to the same.

## Minimum requirements to apply:

- 1. Applicants must have served as a Michigan 4-H Shooting Sports Instructor in the discipline for which they are applying for at least five years as an instructor. Time as a certified teen instructor does count toward these five years. Therefore applicants would be at least 26 years old and those with junior leader experience could be as young as 21 years of age as of January 1<sup>st</sup>.
- 2. Applicants must be current on their 4-H instructor certification in the discipline for which they are applying.
- 3. Applicants must be active in the MI 4-H Shooting Sports Program.
- 4. Applicants must agree to attend and participate fully in ALL steps of the Train the Trainer Program.
- 5. During the training process and, if selected as a state trainer, participants must be willing to travel at least three times per year, to assist/conduct state training and 4-H shooting sports events such as the instructor workshop and state shoot. Trainees/trainers understand that they may incur costs associated with this role and no compensation or reimbursement for those costs is to be expected.
- 6. Those selected as State Instructor Trainers must commit to serve as a state trainer for at least three years upon earning trainer status.
- 7. Those selected as State Instructor Trainers must agree to abide by and help enforce all MI 4-H and Shooting Sports policies. They are expected to continue to be active in their local 4-H Shooting Sports program and present themselves at all times (not just at 4-H sponsored events) as a person of good character, a role model for youth and adults, and as an ambassador of MI 4-H.

## **Application and Process:**

- 1. All applications must be submitted electronically (as an email attachment faxes and hard copies will not be accepted).
- 2. At least two and no more than four letters of reference must be submitted electronically. They must be emailed directly from the reference to Nick Baumgart at <a href="mailto:baumga75@anr.msu.edu">baumga75@anr.msu.edu</a>. References should be from anyone who can attest to your abilities as a teacher/coach, your character, your skills related to the discipline for which you are applying and/or your involvement in 4-H Shooting Sports.
- 3. One reference must be from your county 4-H Program Coordinator or the 4-H Educator responsible for your county if you do not currently have a Program Coordinator for your county.
- 4. One reference must be from another 4-H Shooting Sports Instructor.
- 5. Background checks will be conducted on all applicants.
- 6. The process for review of applicants and selection of "trainees":
  - a. Applicants submit application as detailed above by October 16, 2015
  - b. References submit letters of support for applicant by October 16, 2015
  - c. Committee reviews applications. Applicants will be notified by October 30, 2015 if they have been selected to move on to the interview process or not.
  - d. Interviews will be conducted throughout October and early November. These may be conducted in person, via phone, skype or other method depending on resources available.
  - e. Applicants who are successful in the interview process will be notified by December 15<sup>th</sup> and invited to attend the Train the Trainer Workshop which will be held mid-January/mid-February. As soon as this date and location are established, all applicants will be notified.
  - f. New trainees attend Train the Trainer Workshop.
  - g. New trainees are assigned a mentor at Train the Trainer Workshop.
  - h. New trainees work with mentor between Train the Trainer Workshop and the 4-H Shooting Sports Instructor Certification workshop in April 2016 in preparation to teach at the April workshop.
  - Following the initial trainer Workshop, new trainees will be evaluated by the committee and their mentor to determine the level of additional supervised leadership of training events needed.
  - j. New trainees are approved as MI 4-H State Shooting Sports Trainers.
