General Rules:

- All submissions must be accompanied by a completed entry form. All forms must be signed by the student’s parent or guardian. Entry forms may be photocopied
- Submissions become the property of the City of Leesville Mayor’s Office
- The City of Leesville Mayor’s Office retains the right to publish entries along with the names and likeness of each student.

Poster Contest Grades 3-5

- Must use any of these mediums: paint, felt pens, colored pencils, pastels, crayons, etc.
- Student’s name and daytime phone number or email address of parent or guardian must appear on the back of the poster
- Posters can be in color or black and white

Essay Contest Grades 6-8

- 500-1,000 words typed
- The student’s name and daytime phone number or email address of parent or guardian must appear at the top of the essay
- Must begin with the statement, “If I were Mayor...”
- Judged for grammar, spelling, punctuation, purpose, and originality

Video/PowerPoint Contest Grades 9-12

- Must be at least one-three minutes in length and may be emailed or submitted on a disk
- The student’s name and daytime phone number or email address of parent or guardian must appear in the email or written on the disk.
- Must display the student’s original ideas on what they believe they could/would change if they were mayor.

Mayor for a Day Contest Rules

Grades 3-4 Poster Contest

1. Poster size must be a minimum of 17" and a maximum of 28" in height or width.
2. Students are encouraged to be creative and may use any art medium (i.e. poster paints, felt pens, colored pencils, [pastels, crayons, three-dimensional art, etc.)
3. Posters can be in color or black and white
4. Student's name and daytime phone number or email address of parent/guardian must appear on the back of the poster
5. Entry Form must be attached to the poster in some way
6. Poster must be the original idea/work of the student
7. Must fulfill the purpose statement "If I were Mayor I..."
8. Will be judged for creativity, clarity/sincerity of thought, proper use of grammar, subject relevancy

Grades 5-8 Essay Contest

1. 500-1,000 words typed
2. Student's name and daytime phone number or email address of parent/guardian must appear on the back of the poster
3. Entry Form must be attached to the essay
4. Essay must be the original idea/work of the student
5. Must begin with the statement "If I were Mayor I..."
6. Will be judged for creativity, clarity/sincerity of thought, proper use of grammar, subject relevancy
7. The winning essay will have displayed proper punctuation, spelling, and grammar

Grades 9-12 Video/PowerPoint Contest

1. Must be at least 1-3 minutes in length and may be emailed or submitted on a disk
2. The student's name and daytime phone number or email address of parent/guardian must appear in the email or written on the disk
3. Must display the student's original ideas on what they believe they could/would change if they were mayor
4. Must begin with the statement "If I were Mayor I..."
5. Must be the original idea/work of the student
6. Will be judged for creativity, clarity/sincerity of thought, proper use of grammar, subject relevancy
7. Entry form must be accompanied with the email/disk

What Does a Mayor Do?

The Leesville mayor is elected by the voters in the city to serve as the chair of the city's governing body – the city council. They are the recognized civic leader in the eyes of the community and the person who represents their city to other governments and individuals. The mayor presides over council meetings and participates in discussions. In many cases he or she votes on issues only in cases of a tie. Depending on the City's charter (the equivalent of a constitution), the mayor may also appoint committees to study public policy (in areas such as parks, transportation, community planning, libraries, traffic safety, etc.) with council approval, veto ordinances (city laws) passed by the council, and sign ordinances and other records approved by the council.

Judging Criteria

Judging of the local contest will be conducted by your city officials or other persons appointed by the mayor. In selecting the winners, the judges will consider:

- ✓ **Creativity** – Does the student demonstrate curiosity and originality?
- ✓ **Clarity/Sincerity of Thought** – Is the submission well thought out and organized?
- ✓ **Proper use of Grammar** – Does the submission contain proper spelling, grammar and punctuation?
- ✓ **Subject Relevancy** – Are the major points relevant to the role of a government leader? Does the student demonstrate an understanding of municipal government and the job of mayor?
