


CAMPUS MAP

1A • ALTERNATIVE EQUINE INTERVENTIONS FOR EAST PROGRAMS

Manual therapies such as craniosacral therapy, lymphatic drainage, myofascial therapy, Swedish and sports massage, and advanced energy dynamics can support the healing and rehabilitation process. Learn the what, why and how to best utilize these innovative approaches.

1B • HYBRID PROGRAMING: BUSINESS AND NONPROFIT COLLABORATION FOR A STRONGER HIPPOTHERAPY PROGRAM

While most hippotherapy programs tend to be wrapped up in nonprofit organizations, learn how for-profit and nonprofit models of business can work together to bring services to the community.

Alysa Simms, OT of 15 years, works with children with an array of physical and cognitive disabilities including autism, cerebral palsy, sensory processing disorder, fine motor/coordination delays, ADHD, anxiety disorders and more. She splits her time between working with students primarily diagnosed with autism in the educational setting, addressing physical and cognitive needs in the area of hippotherapy across the age spectrum, and part time hours with older adults in rehabilitation. She is a PATH Intl. Certified Registered Instructor, HPCS, completing Level I and Level II AHA, Inc. courses, and is a co-founder of a private practice specializing in clinical OT, PT and Speech in the unique setting of a working horse farm. Katie Roe is a state licensed occupational therapist, graduating from Towson University BS/ MS occupational therapy program in 2014. Katie has experience working with clients across the lifespan with various cognitive and physical disabilities in home health and outpatient settings, as well as the specialized area of hippotherapy. Katie is a PATH Intl. Certified Registered Instructor in addition to being a professional member of AHA. She has a background in business management from Harford Community College (AAS). Katie is co-founder of a private practice, Unbridled Rehabilitation Services, LLC, which provides specialized clinical therapy (OT/PT/SLP) in areas of early intervention, sensory integration, handwriting improvement, equine-assisted therapies and Strider balance bike camps, to name a few.

1C • EQUINE NUTRITION

Get hands-on knowledge of hay selection and pasture management.

Dr. Amy Burk is an associate professor and coordinator for the equine studies program in the animal and avian sciences department at UMD. She completed her graduate work in equine nutrition as a Pratt Fellow at Virginia Tech. She teaches courses in equine science and management, oversees the equine breeding program, and advises equine studies undergraduates as well as students in the Maryland Equestrian Club. She's given more than 100 invited talks on equine nutrition, pasture management and equine health at the local, regional and national level. Her innovative 5.5 Acre Equine Rotational Grazing Demonstrations Farm has been used to educate more than 600 members of the horse industry.

3A • EQUINE EMERGENCIES: HOW TO BE PREPARED AND HOW TO ACT QUICKLY

Learn basic lameness evaluation and causes, how to detect it and when to call your veterinarian.

Alicia Sorum, DVM, began her love affair with horses at the age of seven, with riding lessons and showing consuming most weekends. She rode for the Penn State Equestrian Team and served as the team president during her senior year. While working in pharmaceutical research in Washington, DC, Alicia made the decision to become a veterinarian and graduated from vet school with high honors and a passion for medicine. Dr. Alicia's veterinary interests include equine dentistry, internal medicine and alternative therapies such as acupuncture. She is pursuing further training at the Chi Institute of Veterinary Acupuncture in Florida and will be a Certified Veterinary Acupuncturist (CVA) in 2016. She also cares for the smaller side of vet medicine by providing care to many of the companion animals owned by her clients. Dr. Alicia is also passionate about retraining racing thoroughbreds. She has adopted and retrained four ex-racehorses so far and always has her eye open for the next prospect. Of course, her most important full-time job is that of mom to three future veterinarians!

4A · COMMON EQUINE DISEASE

Learn basic prevention and intervention.

Dr. Jenn Tacia, DVM, graduated from Michigan State University in 2002. Her desire to become part of a respected profession, while being able to help people and animals, led her to become a veterinarian. She especially enjoys surgery and the challenges of equine lameness. While she was still in vet school, she was especially moved assisting in surgery during an equine caesarian section in which both the mare and the foal were saved. (Equine C-sections are extremely rare, and often the death of the mare, the foal, or both occurs). Dr. Tacia moved to southern Maryland from Michigan in July 2002. She says she has appreciated the wonderful welcome she has received from the community and members of the Tidewater staff. When not working with animals, she enjoys spending time on the river with her husband Shawn and their dogs, Pepper and Chops.

4B • EQUINE-ASSISTED PSYCHOTHERAPY *DE

Explore the horse as a co-therapist.

Edward Pecukonis, MSW, PhD, is an associate professor and director of Maternal and Child Health Training, UMD School of Social Work, Baltimore, MD., assistant professor for UMD Department Family Medicine and Assistant Clinical Professor in the School of Medicine's Department of Psychiatry's Institute for Psychiatry and Human Behavior. Ed has published widely both nationally and internationally, accrued grant funding for UMD and is recipient of 2015 Teacher of the Year, UMD Professional Schools. Ed is lead therapist for the equine-assisted psychotherapy program at LeCheval Stable. Marya Pecukonis, MS, NBCT, is a PATH Intl. Certified Registered Instructor, Equine Specialist in Mental Health and Learning, Special Olympics coach and president of MCET. A licensed certified special educator, job developer, human resource administrator, and transition specialist, she has more than three decades in educational settings working with families and individuals with exceptional needs. She is also the founder and director of LeCheval Stable, a nonprofit organization, PATH Intl. center member and Special Olympics training site located in Howard County, MD. She is excited to chair the region 2 conference for PATH Intl. with her team at UMD. Marya, her husband, Ed, and their three adult children are all avid animal lovers and UMD alumni and soon-tobe graduates.

Certified Advanced Instructor, American Riding Instructor, Certified Level II Centered Riding, Level II Parelli and Special Olympics Certified. Renee is the founder and director of Freedom Hills and Rolling Hills Ranch. Freedom Hills participates in the Special Olympics at county and state levels and has also participated in the National Games. 5A • RESULTS OF PATH INTL. EAL SURVEY

In August PATH Intl. administered a survey to gather data on current trends in equine-assisted learning. The survey was a collaborative effort between multiple equine-assisted professionals and organizations. The purpose of the survey was to gain insight into the trends of equine-assisted learning, to identify future needs and how PATH Intl. may support those efforts.

For the last 15 years, Kathy Alm served as executive director of Little Bit Therapeutic Riding Center, a PATH Intl. Premier Accredited Center in Woodinville, WA, one of the largest organizations in the industry. She grew the previously grassroots organization from a \$280,000 annual operating budget to a professional \$2.1 million organization, leading a staff of 23 full-time employees and building and operating a new \$11 million facility. Kathy has a unique depth of knowledge and understanding of the association and its membership. She served as PATH Intl. region 9 representative on a variety of committees in a leadership capacity and was the association board president in the 2010-2012 term, first joining the board of trustees in 2005. Currently, she is CEO of PATH Intl.
