## **Amy Borman**

Amy Borman, an attorney with Dickinson Wright, represents private and public educational institutions, with a focus on compliance with state and federal laws. She has been a guest speaker at businesses, universities and schools throughout the United States and Europe. Borman assisted Iceland in passing a new education funding law.
