

## Five from South Bend Attend CCS National Convention

Five South Bend Christ Child members attended the September National Christ Child Society Conference in Washington DC. Local chapter attendees were President Peg Riggs, former President Joan Hardig and President Elect Debbie Spillman. In addition, South Bend was well represented by National Vice Presidents Beth Barrett and Deb Low.

Keynote speaker for the conference was Julie Francavilla, a newscaster from Seattle. She addressed a serious problem that our society encounters at all levels: neither the name of the "Christ Child Society" nor our mission of clothing infants and children is familiar to the general public. This is a problem that we have recognized and have tried to address in our South Bend chapter.

The first day meetings addressed onboarding leadership and the responsibilities of local officers. These presentations discussed the efforts necessary to recruit new leaders and strategies to help them fully develop their respective positions. The oral presentation was supported with documents that itemize and explain the duties of chapter officers.

Beth Barrett gave presentations entitled "Challenging Poverty Today." This seminar discussed the different activities that chapters can undertake as a means to positively impact children's lives. South Bend's "Success" tutoring program was highlighted as an example of a program that follows this directive. Other examples were Toledo's parent

support and education program and Pasadena's self-esteem program for fifth and sixth grade students.

The conference included workshops and breakouts discussing recruiting, retaining and remembering membership. Even though the presentations and workshops were educational and informative, a highlight of each day was the interaction with CCS leaders from chapters throughout the nation. Although the chapters might have varied programs, members seemed to have a similar goal: It is imperative to grow our organization in order to assist the children who most need our help!
