Kris Kaufman, SWFWMD SWIM Program, will share the methods and results of the 2014 seagrass mapping study and report on the progress toward established seagrass habitat targets.

Agenda Item I · Call to Order/Welcome

Chair Minning called the meeting to order at 9:07 a.m.

Agenda Item 2 · Public Comment

No public comments were made.

Agenda Item 3 · Approval of the September 11, 2014 Full Agency Meeting Minutes

Upon a motion by Mr. Ash and a second by Mr. Shelton, the meeting summary was approved unanimously.

Agenda Item 4 · Tampa Bay Harbor Dredging Update

Ms. Hershorin, USACE, discussed the recently completed dredging projects at Manatee Harbor and Tampa Harbor, including the Entrance Channel, Egmont Cuts I & 2, and Mullet Key Cut. Sand was placed on Egmont Key and completed by March 5th. Hopper dredges were stopped due to a total of 8 turtle takes. Ms. Hershorin also discussed the status of the 3-D disposal area expansion and associated bird monitoring and projects included in the FY2015 Work Plan, including Big Bend and Manatee Harbor deepening. The USACE will return to a future meeting (June or August) to address the Manatee Harbor deepening project. Members asked questions regarding the use of TEDs, turbidity violations, and the last time Manatee Harbor was dredged. There was additional discussion regarding the beneficial uses of dredged materials and the proposed reevaluation of the dredge hole study.

Agenda Item 5 Summary of Joint TBEP TAC/Habitat Restoration Committee Meeting

Ms. Burke, TBRPC, and Ms. Greening, TBEP, shared highlights from the presentations on blue carbon, ocean acidification, the climate change arctic program and the CCMP update with the full Agency.

Agenda Item 6 · CCMP Update

Ms. Burke summarized written feedback provided by Agency members and reviewed the formal ABM recommendation to the Tampa Bay Estuary Program. A facilitated discussion finalizing these comments was conducted.

Agenda Item 7 · Draft Imperiled Species Management Plan

Ms. Sunquist-Blunden reviewed the 10-year plan to address the conservation needs of multiple species through strategies that minimize threats, reverse negative impacts, and address the complexity of improving habitat conditions at varying scales. Members commended the FWC for making the shift to recognize interference with breeding, feeding, etc. as a take or harm but also urged the Commission to more fully consider plant species protections in the plan.

Agenda Item 8 · Economic Valuation of Tampa Bay

Ms. Burke introduced Randy DeShazo, TBRPC Principal Economic Planner to the Agency. Mr. DeShazo summarized the results of the study published jointly by the Tampa Bay Regional Planning Council and the Tampa Bay Estuary Program in 2014. Mr. DeShazo offered to make himself available for presentations on the subject to various groups throughout the community.

The Executive Steering Committee recommended that the full Agency consider revising article 2 of the Organizational Statement to read:

"The Agency shall serve as the advocate for the Tampa Bay ecosystem, promoting its restoration and protection through responsible, resource-based management; providing a forum for open discussion of issues affecting the ecosystem; educating and encouraging the public to participate in Bay protection and management; and fostering responsible stewardship by commercial and recreational interests."

The Executive Steering Committee did not recommend any changes to membership requirements (article 5) to explicitly include Citrus and Hernando counties at this time.

Agenda Item 5 · Operating Procedures

The Executive Steering Committee did not recommend any changes to the Operating Procedures. Chair Minning designated Ms. Vicki Parsons, Bay Soundings, as the Chair of the Public Information Committee. There was discussion, but no consensus recommendation, regarding whether or not the Legislative Review Committee should remain as a standing committee or transition to an ad hoc task force.

Agenda Item 6 • Other Items

There was lengthy discussion regarding the best method for addressing relevant and timely topics. It was recommended that Ms. Burke share and maintain a spreadsheet of potential future meeting topics to which all members of the Agency could contribute. Ms. Burke also proposed using the December meeting as an "Annual Meeting" where the Agency's accomplishments could be summarized. Mr. Ash suggested that a compendium of position letters authored on behalf of the Agency be documented and included in the accomplishments.
