Dr. Carla Aragón

Dr. Carla Aragón is an Emmy Award-winning journalist with 40 years of broadcast experience. Carla left television news in December 2007 to pursue other interests, which include writing a bilingual children's book called "Dance of the Eggshells/Baile de los Cascarones." The book, published by UNM Press, won the 2010 New Mexico Book Award for Best First Book published by an author. Her presentation of the book on CD won the 2011 International Latino Book Awards for Best Children's Audio Book - Bilingual.

From 2011-2014, Carla was the senior media representative for the Speaker of the House and the House Majority of the New Mexico State Legislature. When not working the legislative session, Carla produces and does on-camera/voice work for various television and radio projects through her company Spirited Voice and Talent. One of the most recent projects was a 13-part TV series on artists for the Spanish Colonial Art Society.

As a television news anchor for KOB-TV, Carla covered all the major stories in New Mexico, including the massive Cerro Grande Fire. The native New Mexican has guided viewers through breaking news coverage of devastating natural disasters, elections and other notable events such as the Albuquerque International Balloon Fiesta.

Before joining KOB-TV in 1994, Aragón spent 11 years in Los Angeles working at KNBC-TV as the morning co-anchor of the top-rated weekday morning newscast, "Today in L.A.," and as a general assignment reporter. She covered the O.J. Simpson Trial, two visits by Pope John Paul II, the Los Angeles riots and several California earthquakes and fires.

Honored several times for her outstanding work in journalism and community service, Aragón was conferred an Honorary Doctorate of Letters from her alma mater, New Mexico State University in May 2009. She won an Emmy Award for "Final Journey," documenting the final days of a hospice patient. She has also been honored with numerous Associated Press and New Mexico Broadcast Association Awards. In July 2007, Aragón was recognized by the Radio TV News Directors Association as one of the founding members of the National Association of Hispanic Journalists. She was also included in the book, "Mujeres Valerosas," (Women of Valor) published by the New Mexico Hispanic Women's Council in 2007. Aragón was named one of the Most Influential Hispanics in the U.S. by Hispanic Business Magazine in 1990. Carla is a member of the advisory board for the Instituto Cervantes; member of the Hispanic Women's Council; a "Pennies for the Homeless" volunteer; a past member and officer of the New Mexico Women's Forum; a former member of the development council for UNM's Children's Hospital; and a former member of the board of trustees of the National Hispanic Cultural Center Foundation.

She enjoys gardening, dancing, traveling, white water rafting and spending time with her husband, Allen Lewis, and their two rescue dogs.

Phillip Rios

Phillip Rios was named Sandoval County Manager in October 2011. The County Manager is the county's chief administrative officer. He is tasked with implementing the policies established by the Board of County Commissioners. The County Manager also serves as liaison between the commission, other elected county officials and county employees to ensure that all county operations are conducted in accordance with state laws and regulations.

Mr. Rios came to Sandoval County as Director of Community Services in 1999, following a nine-year stint as chief administrator for the Village of Corrales.

In 2004, Mr. Rios was asked to take over the county's Public Works Department. His approach to leading that department impressed the Board of County Commissioners, which asked him to step in as interim County Manager when the county's top executive post came open in May 2011. Six months later, after further demonstrating his abilities as an effective leader and manager, the commissioners voted unanimously to make Mr. Rios the permanent county manager.

"The leadership skills I gained as an Air Force military officer certainly have helped me in working with our citizens and county employees, as well dealing with issues that come up in a daily basis," he says. "I have always believed in what President John F. Kennedy said in his 1961 Inaugural Address; ask not what your country can do for you—ask what you can do for your country. That's why public service has been a very big part of my life."

In his spare time, Mr. Rios gives back to the community by having served as a coach and board member for the Young America Football League for 19 years. When he's not working, coaching football or playing golf, he enjoys spending time with his wife and family.

DSAP consists of the following program components: 24/7 Central Intake, 50 bed social model detox, 80 bed supportive aftercare (co-educational transitional housing) jail and community based Addictions Treatment Programs, 12 bed Medical Observation and Treatment Services, and Community Case Management Services.

March 1994 – February 2002 Director, Bernalillo County (Adult) Detention Center

(BCDC) – Reassumed responsibility; provide day-to-day management of three facilities (Main, Westside and Satellite); developed and implemented the Community Custody Program, 150 bed Detox and the Community Sobering Service Center. Initiated over 22 separate population management programs, complementing the Pre-trial Service component of BCDC. Provided management oversight of over 500 employees; managed an operating budget of \$38 million dollars. Managed the facility, which books over 40,000 individuals each year and has an average daily population of 1600 inmates including those modified to Community Custody. Participated in the design and construction of the new Metropolitan Detention Center. Improved on the “Modular” Corrections Officer Training Academy concept along with enhanced inservice training program. Earned American Corrections Association and National Commission on Correctional Health Care Accreditation and continued into the new 2300 bed Metropolitan Detention Center.

Dec 1993 – Dec 1995 Director, Bernalillo County (Adult) Detention Center

Managed the day-to-day operation of the adult detention center, which has an average daily population of 1,350 inmates with approximately 35,000 bookings each year. Provided oversight for 336 staff with an operating budget of over \$17 million dollars. Collaborated on the development of a Federal Settlement Agreement pursuant to a class action lawsuit. Developed and implemented programs and initiatives to achieve substantial compliance to the Agreement. Developed the first “Modular” Corrections Officer Training Academy. Also created a shift schedule that provided a minimum of 80 hours of continued inservice training time per year without overtime.

Mar 1991 – April 1998 Director, Bernalillo County Juvenile Detention Center

Assumed responsibility for all facets, i.e., personnel, budget, purchasing and planning etc. along with the day-to-day operation of the facility. Managed 134 FTE and 20 part-time staff and a budget of over \$4 million dollars. Assisted the facility in earning first American Corrections Association Accreditation.

Dec 1980 – Mar 1991 Division Supervisor, Clark County Juvenile Court Services, Las Vegas, Nevada

Director, Child Haven (one year). Child Haven is a 72 bed short-term (one day to five months) residential facility for abused and neglected children, ranging in age from five days old to 17 years. Directed 65 staff and managed an operating budget of \$2.5 million.

Director, Admissions/Intake (six years). The Admissions/Intake Division was responsible for processing approximately 25,000 youth each year referred to Clark County Juvenile Court Services. In addition to the Intake responsibility for delinquent and CHINS referrals, the Division also received, investigated and provided direct services to neglected children. The Division had 60 staff and a budget of \$2 million.

Director, Detention/3rd Cottage (three years). Detention is a 112-bed short-term (one day to four months) facility for juveniles charged with delinquent offenses. It included a 24-bed 120-day highly structured (boot-camp style) facility for post-adjudicated youth. The Division has 75 FTE and 30 part-time staff, with a budget over \$4 million dollars.
