

DAY 2 - April 19 Wednesday Bethlehem

Arrive in Tel Aviv and travel to Bethlehem where you will have dinner and rest overnight.

DAY 3 - April 20 Thursday Bethlehem

Visit the Church of the Nativitity, Shepherd's Field, the Herodion, the Threshing Floors, and the Palestinian Wi'am Center.

DAY 4 - April 21 Friday

Visit Bethany, Qumran, the Dead Sea, Jericho and the Old Testament Tel of Jericho. Remember the baptism of Jesus at Qasr el Yehud on the River Jordan. View St. George Monastery from across Wadi Kelt.

DAY 5 - April 22 Saturday North to the Galilee

Travel to the Mediterranean Coast to visit Caesarea Maritima. Continue north to Tel Megiddo, Sepphoris and Nazareth Village.

DAY 6 - April 23 Sunday Around the Sea of Galilee

Visit Magdala, Tabgha, Capernaum, and the Mount of Beatitudes. Enjoy a boat ride across the Sea of Galilee.

DAY 7 - April 24 Monday Upper Galilee

Travel north to Dan, the Banyas Nature Preserve, Caesarea Philippi, Gamla, Wadi Ha'mam and enjoy a possible bedouin encounter.

DAY 8 - April 25 Tuesday South through Samaria

Visit the Church of the Annunciation in Nazareth. Head south through Samaria. Visit Sebastia, Sychar, Shechem and Shiloh.

DAY 9 - April 26 Wednesday Jerusalem

Visit the Israel Museum where you will see the Dead Sea Scrolls exhibit and the Model of Jerusalem. Enter the Old City of Jerusalem to visit St. Anne's Church, the Temple Mount, the Western Wall, the Teaching Steps, the Southern Wall Excavations, and Hezekiah's Tunnel. Enjoy free time in the Old City.



DAY 10 - April 27 Thursday Jerusalem

Stand atop the Mount of Olives. Walk through the Garden of Gethsemane to the Church of All Nations. Visit St. Peter in Gallicantu to see the House of the High Priest Caiaphas. Explore the Church of the Holy Sepulchre and the Garden Tomb. After dinner, travel to the airport for flight to USA.

REGISTRATIONS RECEIVED after 1/3/17: We welcome registrations after 1/3/17.

Registrations received between 1/3/17 – 1/18/17 will incur a \$100 per person fee. Registrations received between 1/19/17 – 2/2/17 will incur a \$200 per person fee.

Registrations received after 2/3/17 will incur an additional fee based on air availability. Additional fees will be advised upon registration.

CANCELLATION FEES: 100% of Cancellation Fees are covered by the optional Travel Protection Program, provided premium has been paid and reason for cancellation is insurable. Those who do not take travel protection should be aware of the following cancellation penalties: From day of registration to 105 days prior to departure, you will be charged the \$100 non-refundable administrative fee plus any airline fees.
