# First Annual ARTS BATTLE

## A Live competitive painting event!

The Great Plains Arts Incubator is dedicated to connecting local artists with their community and so invites all visual artists 18 years or older to participate in the first annual Great Plains Arts Battle. Art Battle is live competitive painting where painters create the best work they can across three rounds of live public painting, each round lasting only 30 minutes. In those 30min, the artist goes from blank canvas to a completed work, subject matter is up to the artist. The event is open to the public and as the audience, votes for the winners of each round where they then advance to the final round. 1st, 2nd -3rd place winners of the final round receive a trophy. 1st place winner of the final round will receive a solo exhibition in a public venue still to be determined.

Artists who enter are encouraged to bring up two of their completed works to be sold at a silent auction that will be held during the event. 100% of the proceeds from the silent auction remain with the artists. Artists are responsible for preparing their work for display in the silent auction, for providing easels for silent auction display that are marked/identified as the artist's property, and for collecting the money from the winning bidder at the end of the day. We suggest that the artist be prepared to take a credit card. All art created during the Battle will be sold at the end of the event in a live auction and the artists retain 75% of the live auction proceeds. Artists retain copyright of their art.

**Participant Cost:** \$10 with student ID, \$20 all others. Must be paid no later than September 19th to Great Plains Technology Center Book Store. May be mailed with the application to Building 100, 4500 W. Lee Blvd., Lawton, OK 73505.
