#### **Policy Review**

At its February 24, 2015, School Board meeting, members reviewed recommended updates to policy from the Illinois Association of School Boards' Policy Reference Education Subscription Service (PRESS). Following the 1<sup>st</sup> read, the Board asked that Policy 2:140 – Communications To and From The Board be tabled until the next Policy Subcommittee meeting. Following legal review, the Board was advised that the Policy, in its current form, meets the requirements set in P.A. 98-930. With three new Board members preparing to be seated at the April turnover meeting, the Board suggested that this policy be reviewed, by the Policy Subcommittee to determine if communication practices should be modified. Additionally, further edits to Policy 6:280 – Grading, Reporting and Promotion, as well as, 6:340 – Student Testing and Assessment Program, are incorporated.
