# SIGNIFICANT DECISIONS

In *National Security Fire & Casualty Co. v. DeWitt*, No. 1091225 (Ala., November 18, 2011), the Supreme Court reversed a trial court order certifying a class action with respect to claims that an insurance company had failed to include general contractor overhead charges in adjusting claims. The Court found that common questions of fact would not predominate because it appeared that claim class member’s claim would have to be considered on a case-by-case basis.

In *Dzwonkowski v. Sonitrol of Mobile, Inc.*, No. 1100929 (Ala., November 18, 2011), the Supreme Court held that the trial court did not disregard the instructions of the appellate court in remanding “for further proceedings” a case in which a summary judgment had been reversed by conducting an evidentiary hearing with an advisory jury. The court also held that the trial court did not violate the law-of-the-case doctrine by entering a judgment based on judicial estoppel, even though a similar judgment had previously been reversed on a prior appeal, because there had been a significant change in the Alabama law of judicial estoppel in the interim.

In *Stephens v. Fines Recycling, Inc.*, No. 1091111, (Ala., November 10, 2001), the Supreme Court discussed the distinction between ordering separate trials of legal and equitable claims versus severing the claims into separate actions. Even though the trial court at one point used the term “sever” in describing what was to occur, the Supreme Court concluded that the overall facts and circumstances indicated that the trial court merely intended to conduct separate trials of the equitable claims after the legal claims were resolved. According, no appeal could occur from the judgment on the legal claims without a Rule 54(b) certification, and the Court ruled that the trial court’s certification was invalid here because all claims were not resolved. Accordingly, the Court dismissed the appeal.

The bankruptcy administrator is responsible for supervising trustees and debtors in possession and ensuring that such persons effectively administer the district’s bankruptcy estates and Section 1334 of Title 28, United States Code.

Members of the bar and the public are invited to comment on whether Mr. Bedsole should be recommended for reappointment by the **COURT OF APPEALS**. She not only has the heart for our pro bono program, but she is the perfect visionary for where VLP is headed. And VLP is going places...literally. We started serving low income individuals and families in Washington and Clarke counties this past year. We are hoping that some of you will be able to help us out with these cases as there are limited attorneys in these counties. We are in the process of working with the members of the Baldwin County Bar Association to expand into Baldwin County in the near future. The regional based, versus county based, pro bono model will provide greater access to justice to those needing our services, and we are excited about the expansion. We know that our great bar association will support this effort, and we look forward to working with the lawyers of the Baldwin County bar!

Additionally, we are initiating the "**ATTORNEY FOR THE DAY**" program in District Court which will allow you to directly serve individuals at the court house in a short "advice clinic" setting. We expect this program to be a beneficial not only to VLP clients, but the court system as well. Call the VLP office if you would like to sign up. It is an easy way to help out on a "limited scope" basis, especially if your own practice demands right now are keeping you from taking VLP cases.

I want to also thank our wonderful staff for the amazing work they do. **ARIANA MOORE**, our Associate Director, is the consummate multi-tasker. She works very hard to make sure our clients are matched with the right lawyers, and she does a great job. VLP was also blessed with another wonderful Jesuit Volunteer in 2011, **MEGAN COLEMAN**.

Because of your volunteer time and donations, VLP was able to refer 795 cases to lawyers and 500 cases were closed in 2011. 410 of you graciously accepted cases, and 4170 volunteer hours were donated. You also donated a record \$46,000 to our program this past year, which is so greatly appreciated especially in this lean year and considering United Way defunded us. We now have 800 attorneys on the VLP panel, which is 70% of our bar association. JUDGE PITTMAN WAS BORN IN ENTERPRISE AND GRADUATED FROM THE UNIVERSITY OF ALABAMA LAW SCHOOL IN 1940. HE WAS A U.S. NAVY VETERAN. HE SERVED AS A CIRCUIT JUDGE FOR THE SEVENTEENTH JUDICIAL CIRCUIT (GREENE, MARENGO AND SUMTER COUNTIES) FROM 1951-1966, AND SERVED AS A UNITED STATES DISTRICT COURT JUDGE FOR THE SOUTHERN DISTRICT OF ALABAMA FROM 1966 UNTIL HIS RETIREMENT ON MARCH 28, 2006, HIS 90TH BIRTHDAY. HE WAS AN ACTIVE MEMBER OF THE FIRST BAPTIST CHURCH OF MOBILE. HE WAS PREDECEASED BY HIS FIRST WIFE, AND IS SURVIVED BY HIS WIFE **LILY LEA VERNEUILLE PITTMAN**; FOUR CHILDREN; TWELVE GRANDCHILDREN; AND EIGHT GREAT-GRANDCHILDREN. JUDGE PITTMAN WILL BE GREATLY MISSED BY ALL WHO HAD THE OPPORTUNITY TO PRACTICE IN HIS COURT.
