As **BUZZ LIGHTYEAR** says, *“To infinity and beyond!”* Or at least to Chatom and Grove Hill.

The work that our bar's **VOLUNTEER LAWYERS PROGRAM** does is astounding and we have every right to be proud of it. Under the recent leadership of **DAVID PEELER** and now **LISA COOPER**, the lawyer participation rate has grown to almost 70% (three times the national average), and we routinely handle as many cases a year (close to a thousand) as the state bar program and many more than the Birmingham and Huntsville programs. But the **MOBILE BAR ASSOCIATION VLP** is getting ready to take another small leap that is very exciting.

Some quick background: Alabama has three countywide pro bono programs (Mobile, Birmingham and Huntsville) and then a state bar VLP which covers the other sixty-four counties -- including some of the state's poorest areas. The Birmingham and Huntsville programs are taking off under new bar leadership and staff, and the state bar VLP has outstanding staff and leadership. But as we have learned here in Mobile, a pro bono program needs a local presence in order to run at its highest level; you must recruit lawyers, meet with judges, do in-person intake, conduct clinics and do public outreach to let the public know about your services. (A recent survey found that only 20% of Alabamians even know about the availability of free legal help.)

In Mobile we have the same number of paid VLP staff (four) covering one county as the state bar has for 64 counties; as a result, the number of cases we handle in Mobile is about the same as in those 64 counties. The state's staff of four in a centralized location simply can't serve a state stretching from Gulf Shores to Muscle Shoals in a truly effective manner. The state's rural counties in particular are not getting the help they need.

The upshot is that the state bar VLP has asked the Mobile VLP to consider gradually expanding into adjacent counties and eventually becoming a regional program in southwest Alabama. If things work out, the other VLP's will do the same until there are five or so regional VLP's with offices possibly in Mobile, Montgomery, Tuscaloosa, Birmingham, and Huntsville.

The Mobile VLP board, with the consent of the MBA executive committee, has recently started taking some steps towards this expansion. Our VLP tentatively plans to take over pro bono case assignments in Clarke and Washington counties later this year. The initial

I hope you noticed elsewhere in this publication the notice about an honor being bestowed upon our own **MR. HARRY SEALE** by the **ALABAMA STATE BAR**. Well, I can't resist adding this article I read in the Press Register's "**YESTERDAY'S NEWS**" which are excerpts from past editions of the Press-Register compiled by **CAMMIE EAST COWAN**, dated Wednesday, March 8, 1961

plan is that our folks will meet with the local lawyers and judges, get them on board, and then start handling intake of cases from those areas. The VLP will recruit local lawyers in those counties but if necessary will ask Mobile lawyers to help out. The VLP will probably set up clinics (such as it has done recently in Bayou La Batre) and establish intake sessions at a regular location -- perhaps the local courthouse or DHR office. The VLP will also conduct outreach to local social service providers and churches to let them know about the program, as is done in Mobile now.

All this is in the preliminary stages and there are a lot of issues to be ironed out. The VLP board in particular doesn't want to do anything that might undermine the strong support of the Mobile bar which has been the basis of its success over the last twenty years. But there are many low-income Alabamians in our surrounding counties who need legal help and are not getting it. Anyway, congratulations to the VLP board members for their willingness to take on new projects and to share the good thing we have going with our immediate neighbors.





SIGNIFICANT DECISIONS

In a case of first impression, the Supreme Court in *Ex parte Textron, Inc.*, No. 1100032 (Ala., January 14, 2011), held that a lender did not waive its right to assert a Rhode Island forum selection clause against a borrower with respect to general matters under the loan agreement by instituting a detinue action against the Alabama collateral in an Alabama federal court because the Rhode Island court could not have jurisdictionally granted recovery against property located in Alabama.

Overruling to the extent inconsistent the prior cases of *Russell v. Russell*, 758 So.2d 533 (Ala.1999), and *Scott v. Boykin*, 900 So.2d 410 (Ala.2004), the Supreme Court in *Oliver v. Shealey*, No. 1091707 (Ala., January 14, 2011), held that Rule 3(c) of the **ALABAMA RULES OF APPELLATE PROCEDURE** imposed a mandatory, and not discretionary, requirement on a circuit court to correct a notice of appeal improperly directed to the circuit court to reflect the appeal to the proper appellate court. The Court also held, by strong implication, that the **RULES OF APPELLATE PROCEDURE** applied to appeals taken to circuit courts, even when the circuit court was not a jurisdictional appellate court in the case.

In *Ex parte Tucker*, No. 1090445 (Ala., January 7, 2011), the Supreme Court held that documents requested from a party's law firm concerning financial payment to the firm and trust account holdings on behalf of that client were not protected by the attorney-client privilege.

As a separate matter of interest, it should be noted that a lawyer received a public reprimand from the Alabama State Bar after being found in contempt by a probate court judge for failing to appear at a hearing that had been duly noticed. See **ASB No. 10-462**.

VOLUNTEER LAWYER PROGRAM

Family law is one of the areas of greatest need here in Mobile. Of the 894 cases opened last year, 350 involved family law issues. The **FAMILY LAW COMMITTEE OF THE VLP BOARD** is striving to strengthen our ability to serve Mobilians in this broad field. Our committee members are **JENNIFER McDONALD, LUKE COLEY, RICK WILLIAMS, MARY PILCHER, and KATE BOLTON BONNICI**. We are working to both expand our areas of coverage and to deepen our expertise in those areas we already cover. We will be posting helpful family law guidelines to our website (www.vlpmobile.org), which will help walk panel attorneys through core family law matters. These guidelines were created by family law practitioners on our committee and should prove to be a quick and useful reference for our volunteer lawyers. We are also in the process of fortifying our mentorship program by pairing new panel attorneys with experienced mentors. In an effort to expand our services to reach more people in need, we will be launching a program with the **DEPARTMENT OF HUMAN RESOURCES**, through which we assist with foster parent adoptions. We are also in the process of planning divorce clinics, which will enable us to serve broader numbers. As always, we depend on our dedicated members of the bar and staff to make this good work possible – thank you all!

This month, VLP would like to give special appreciation to panel attorney **LATISHA D. RHODES**. Latisha is an associate at **ALFORD CLAUSEN & McDONALD**. She graduated from the **UNIVERSITY OF ALABAMA SCHOOL OF LAW** in 2009 and then began work at **ALFORD CLAUSEN**.
