Many of us have had the great good luck at one time or another to have had the opportunity to meet and enjoy a conversation with a Mobile native, and genuine American hero. I speak of former **U.S. SENATOR JEREMIAH A. DENTON, ADMIRAL DENTON**.

I have met and served with many men who are or were genuine American heros in peacetime and in war, but none really seem to me to be on the level at which I rate Jerry. He and I shared a Vietnam past that kind of makes those of us of that era somewhat like brothers, but maybe more, comrades-in-arms.

Truthfully, combat is as bad as you might imagine it to be, but surviving it is far more euphoric than you can imagine. I have always thought that what Jerry endured for seven years in hell was not survivable mentally. The fiendish captivity he endured didn't crush him or his spirit but made him a giant. Surviving really does make you believe that the rest of your life is "gravy".

I was fortunate to have had the honor of representing the Admiral for four decades and it has been a very interesting chapter in my life book. You can't fathom how wordlessly embarrassed you can be made to feel when a man like Jerry tells you "God, I respect you infantry guys, doing that stuff you did day after day." The man never really appreciated how badly he was treated. **JEREMIAH DENTON** died March 28, 2014, but what a statement he made for God and country as the first returning prisoner of war off the plane when he said "God bless America." The likes of Jerry Denton will not pass our way again.






