When I was a young lawyer and dinosaurs roamed the earth, I spent a lot of time in the county law library. Westlaw had been invented but was very expensive, so if you wanted to research cases outside Alabama you basically had to go to the law library. During my many afternoons (and some evenings) there, I always studied the old bar composite photographs from the 1950's that hung on the walls. I laughed to see the senior members of the bar as young pups -- in many cases with goofy haircuts and unflattering glasses. Of course, the bar association depicted in those composites was much smaller and also much less diverse than it is now. But the fact that even as a fledgling lawyer I knew many of the attorneys who had practiced in Mobile thirty or forty years before me gave me a sense of this bar's tremendous community and continuity.

In member responses to the bar association's annual survey, probably the most frequent suggestion is that the association should promote collegiality and socialization among members of the local bench and bar. I've always thought that the collegiality of the Mobile bar makes practicing law here more enjoyable than in other cities.

But we can probably do better. As local lawyers have expanded their practices geographically and lawyers from other cities now practice in Mobile, the Friday morning motion docket is not the social gathering it once was. The local federal courts rarely have oral argument, so that's not an opportunity to see your fellow lawyers. Our last photo directory was in 2005 and even that was a couple of years old by the time it was printed, so it's not easy to refresh yourself on names. The **YOUNG LAWYERS SECTION** does a great job with its monthly gatherings and charitable work, but we can improve in capturing those energies and talents in the regular bar association as well.

Barbara and Tammy are working on a new bar photo directory--available not just online but also in printable form. I'll ask the entertainment committee to look at revamping the holiday party and perhaps adding a summer party or other events. I have found that working on bar committees is a great way to get to know other lawyers that you don't usually encounter; please contact Barbara or me if there is a committee or section that you are not on but would like to join. And I'm going to ask the bar executive committee to establish a new public service committee which will provide additional opportunities for Mobile lawyers to work together for a common good.

## SIGNIFICANT DECISIONS

In *Ex parte Renovations Unlimited, LLC*, No. 1090812 (Ala., October 15, 2010), the Supreme Court held that a party was not entitled to conduct pre-lawsuit discovery against a building contractor where the party had previously entered into a settlement and released the building contractor from liability.

In *Cooner v. Alabama State Bar*, No. 1090944 (Ala., October 8, 2010), the Supreme Court held that the Alabama Rules of Civil Procedure apply generally in determining the timing for appeals involving attorney disciplinary proceedings and further ruled that an attorney was “related” to his aunt’s husband, even after the aunt had died, for purposes of permitting the attorney to draft an irrevocable trust agreement under which the attorney was named as one of 13 beneficiaries.



### PROBATE COURT JUDICIAL FORMS

The Probate Court has now completed a project that has been pending for several years. The Court’s form bank is now available to LAWYERS ONLY on the Court’s Internet web site.

To access the forms, an attorney must first request access to them. To request access, the attorney must login to the Judicial Forms Page with the same email address and password they use to access the Judicial Calendar and Search page. Once logged in, they will enter their Bar ID and submit their registration to the forms. They will receive an email to confirm their registration. Probate Court IT will research the Alabama State Bar’s website to confirm attorney status and will then grant access to the Forms. The attorney will receive an email once we have accepted their registration. Once their registration is accepted, they can simply login to the Judicial Forms page with their email address and password to view the Judicial Forms in PDF format.

### COURTHOUSE COMMITTEE/SECTION

REPORT-CHAIR Y.D. LOTT, JR.

Requests for concerns about the Courthouse/s were circulated.

Examples were as follows:

1. Not enough parking of all types for the Court's business, but certainly seriously lacking in handicapped parking and ramps and entrances.
2. Possible fire hazard in main Courthouse because passes don't always allow egress from the stairwell on the ground floor or other given floors.
3. Legal advice and form preparation is time consuming for normal flow of business at the counter at District Court--- a major increase here.
4. Pleadings signed by paralegals in the name of the attorneys have shown up in Circuit Court and should be viewed carefully under Rule 11 A.R.C.P. for responsibility.
5. Probate Court possibly could use a "you are here" destination map like at the mall until the folks learn their way around.
6. Attorneys should respect a reasonable dress code to appear in court.

The District Court Judges have agreed to implement Chief Justice Cobb's District Court mediation Initiative for the Small Claims Court in Mobile County. Attorney's who are on the Mediation Roster can get their required 10 hours of pro bono mediation per year by providing the service in the Small Claims Court. # 2010 ANNUAL REPORT

**Mary Margaret Bailey, Chair**

The Mobile Bar Foundation is now in its 16th year and to date has accumulated a fund of \$589,586. During the past year, the Foundation raised \$49,050 from membership donations, \$775 from memorial/honorary donations, and \$1,055 from our silent auction fundraiser during the Bench and Bar Conference.

A portion of the funds raised was given away as grants to eight local charitable organizations. The largest single grant was \$20,000 to the Mobile Bar Association's Volunteer Lawyer Program. Another \$22,500 was divided between these deserving organizations: Mobile Area Education Foundation; CASA Mobile, Inc.; Adoption Rocks, Inc.; Big Brothers Big Sisters of South Alabama; HandsOn South Alabama; Mobile United and Assistance League of Mobile.

It is the continued support of the members of the Mobile Bar Association which made these grants possible. You can be proud of your Foundation!

When Tom Deas was a teenager, his father, Sam, hosted a BBQ for his father, Walter, and Walter's twin brother, Alonzo, (Thus, Samuel Alonzo Deas.) The BBQ sauce was secret, but Ma (Addie) Deas, bought the stuff.

You will need:



- Boston butts and pork ribs
- Conecuh sausage for the cooks
- 1 5-gallon stainless steel pot with lid
- 4 quarts tomato catsup
- 4 bottles French dressin
- 1 large bottle of Texas Pete hot sauce
- 4 quarts A-1 sauce
- 6 cloves crushed garlic
- 5 lbs white Vidalia onion
- 2 bottles dry wine
- 2 lb butter
- 1 stalk celery
- 4 pods bell pepper
- 1 box brown sugar
- A few bay leaves (remove after an hour)
- 6 lemons (sliced)

Cook on medium heat – stir and stir; simmer for at least 4 hours; add salt and pepper to taste. (You may want to add jalapeno peppers)
