The local indigent defense advisory committee has recommended to the state finance department that Mobile County be allowed to continue its private appointment system. If the finance department objects to that recommendation, the circuit can appeal to a committee on which **JUDGE LOCKETT** sits. The local committee is made up of **JUDGE CHARLIE GRADDICK** as presiding judge, bar commissioner appointees **GLENN DAVISON, ASHLEY CAMERON WHITE, JAMES BRANDYBURG**, and me as local bar president.

I'm very happy to report that, as of this writing, a total of 74 lawyers and legal staff are participating in the **BIG BROTHER BIG SISTER** in-school mentoring program. I made a presentation to the bar commissioners on September 16th about proposed rule changes regarding "limited scope representation." The proposed rules will establish procedures for lawyers to provide legal help either in or outside court on a limited scope basis, including allowing lawyers to withdraw from a case in which they have agreed to handle only a certain hearing. The proposed rule changes will come up for a vote by the bar commissioners in November and, if approved, will go to the Alabama Supreme Court for consideration. I think the proposed changes will create a win/win situation because middle-income clients will gain access to legal help they otherwise couldn't afford and lawyers will earn fees that they otherwise would not have received -- that has been the experience in other states.

Please make plans to attend the VLP "BROADWAY BRIEFS" auction and dinner theatre at the Marriott Hotel on October 27th at 6:00 p.m. Call the VLP office at 433-6693 to order your tickets. Be sure to introduce yourself to new VLP executive director Shannon Shelley-Tremblay if you haven't met her yet.

The Volunteer Lawyers Program board has been extremely busy. In addition to Pro Bono Week and the Broadway Briefs show in October, the VLP is also (1) expanding into Choctaw and Washington counties this month; (2) organizing clinics at the courthouse; and (3) working on setting up a new Homeless Experience Legal Protection (HELP) program in Mobile to help homeless persons overcome legal obstacles which prevent them from becoming employed and housed. SIGNIFICANT DECISIONS

In a criminal case of first impression, the *Supreme Court in Ex parte Brown*, Case No. 1091767 (Ala., June 30, 2011), while acknowledging that conducting such an examination outside the presence of the jury might be the preferred general rule, refused to adopt a per se rule requiring the trial court to determine a child witness' ability to understand his or her obligation to tell the truth outside the presence of the jury and declined to require the trial court to conduct a separate evaluation concerning the credibility of the child witness' testimony.

In another criminal case of first impression, the Supreme Court in *Ex parte State, No. 1100640* (Ala., June 30, 2011), held that the crime of assault in the first degree, to the extent it required a showing that the victim had suffered disfigurement, could be proven by lay testimony of the disfigurement and that expert testimony was not required.

In a case of first impression, the Supreme Court in *First Union National Bank of Florida v. Lee County Commission*, No. 1090804 (Ala., June 30, 2011), ruled that a mortgage holder was not entitled to payment of excess funds received from a tax sale because the mortgage holder, while having legal title to the property, was not an "owner" within the meaning of the tax sale statute.

In the procedurally complex case of *Ryals v. Lathan Co.*, No. 1091673 (Ala., June 17, 2011), the Supreme Court held that a plaintiff could not substitute real parties for fictitious parties under A.R.C.P. 4(f) after a final judgment had been entered. The Court also held that when a plaintiff filed an "amended" complaint after judgment had been entered adding two new parties and a new claim, it could not be considered a separate action unless it were actually treated as such procedurally.

In *Nationwide Mutual Insurance Co. v. J-Mar Machine & Pump, Inc.*, No. 1090685 (Ala., June 17, 2011), the Supreme Court held that an insurance company had the right to cancel a policy of insurance and had properly done so through written notice. The Court further held that the insured's payment of an additional premium, while deposited by the insurance company, did not constitute a waiver of the cancellation because the insurance company timely issued a partial refund of the premium consistent with the terms of the policy.

In *Ex parte E.R.G.*, No. 1090883 (Ala., June 10, 2011), the Supreme Court declared unconstitutional the Alabama Grandparent Visitation Act, Ala. Code § 30-3-4.1, which vested certain visitation rights with minor children in grandparents.

Over a vigorous dissent and overruling *McKenzie v. Killian*, 887 So.2d 861 (Ala.2004), the Supreme Court in *Ex parte Capstone Building Corp.*, No. 1090966 (Ala., June 3, 2011), held that claims for wantonness were not governed by the six-year statute of limitations in Ala. Code § 6-2-34 but rather by the two-year statute of limitations in Ala. Code § 6-2-38. In rejecting application of the six-year statute, the Court rejected both the notion that wantonness claims could be embraced within the meaning of claims for "trespass" and the notion that wantonness should be treated the same as claims for intentional torts generally thought of as being governed by the six-year limitations period.

Over three dissenting votes, the Supreme Court in *Lane v. State*, No. 1091045 (Ala., May 27, 2011), held that an indigent defendant for whom court appointed counsel had been appointed did not have a constitutional right to keep the same court-appointed counsel in light of the close relationship that had developed between them.





MOBILE BAR'S "BIG"-TIME MENTORING EFFORT

The members of the Mobile Bar and their staffs have distinguished themselves by volunteering in significant numbers to serve as school-based mentors for the Big Brothers-Big Sisters program. Forty-six new lawyers and staff members have qualified and have been matched with "Littles" at Howard Elementary School in Mobile. Program Coordinator Aimee' Risser says the school's principal and teachers are ecstatic over the response.

The new "Bigs" join 28 lawyers and staff who are mentoring at Brazier Elementary, bringing the total number of legal "Bigs" to 74.

Thanks to all those who volunteered, and special thanks to the offices of the District Attorney and U. S. Attorney, which between them provided almost half the volunteers.
