What you don't hear much is a lawyer in Mobile saying "Sure, I enjoy the long hours and incredible stress of practicing law, but I just wish my colleagues would treat me worse."

Of all the things in our professional lives that drive up our blood pressure and keep us awake at night fuming, the aggravations and frustrations of dealing with each other top the list.

The Mobile Bar has grown, but we are still a fairly small, close group. Whether we practice trial work, bankruptcy, criminal law, domestic law, corporate law or something else, we generally deal with the same local lawyers repeatedly and regularly. We know each other, send our kids to the same schools, live in the same neighborhoods and go to the same churches. We are around each other constantly in conference rooms, courtrooms, meetings, recitals, ball games and grocery stores.

2. Avoid using e-mails and letters to address disagreements. They only make them worse. It is too easy to misunderstand or be misunderstood in e-mails and letters. It is too easy to make snarkier comments than I ever would say in person. It is too easy to push the send button before I have gathered my wits, my thoughts and my composure.

3. Try to give the benefit of the doubt when there is more than one way to interpret what my opponent is doing. Lawyers are trained to be wary, and need to be. That is not the same thing as being suspicious. Our Bar Association is filled with honest, hard-working, conscientious people. I need to remember that.

4. Go the extra mile to work things out, rather than going to DEFCON ONE as soon as there is a hint of conflict. The pin can always be put back in the grenade if you don't let go of the handle.

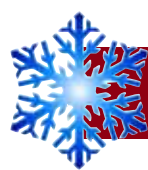
5. Spend a little time getting to know my opponents socially, apart from our case or matter. Ask questions about family, interests and background. I have a lot in common with most lawyers on the other side.

6. Resist my worst impulses in court or in depositions to interrupt, accuse, insult, goad, ridicule or embarrass my opponent. I am supposed to be a professional, and I need to act like one.

7. Never, ever threaten the other lawyer with sanctions, a grievance, a whipping or anything else. Don't tolerate threats against others. That too is part of being a member of this profession.

8. Respect my opponent's efforts to represent his or her client zealously as the same responsibility that I have, rather than demonizing him or her for being in my way. We are both advocates, and neither is morally superior to the other.

I can do better as a fellow lawyer and a member of this Bar Association, and I am going to try. I could use your help.

SIGNIFICANT DECISIONS

In a lengthy opinion addressing an issue of first impression, the Supreme Court in *Ex parte Bole, No. 1110868* (Ala., August 31, 2012), held that the circuit lacked subject matter jurisdiction over defamation and relating tort claims by a Methodist minister against a member of his former congregation because the claims would necessarily have to involve an impermissible intrusion into the inner workings of the Church’s disciplinary proceedings involving the minister.

Over three dissenting votes in another case of first impression, the Supreme Court in *Nationwide Mutual Insurance Co. v. Thomas, No. 1101332* (Ala., August 24, 2012), responded to a certified question from a federal court by declaring that a “carry-for-a-fee” exclusion in an automobile liability policy, under which coverage when the vehicle operator was delivering items or people on behalf of another for a fee, was valid. In answering a second certified question, the Court stated that the exclusion terminated as soon as the last item was delivered and, thus, was not applicable while the operator was returning to his place of employment after making the last delivery. The dissent primarily argued that this was not a declaration of law per se but merely an interpretation of a contract and, thus, not something subject to being resolved by way of a certified question.

In a complex case involving the jurisdiction of probate courts, the Supreme Court in *Hoff v. Goyer, No. 1111078* (Ala., August 17, 2012), held that the removal of a conservatorship proceeding from probate to circuit court was governed by Ala. Code § 26-2-3 (applying to guardianship and conservatorship proceedings) and not by Ala. Code § 12-11-41 (applying to decedents’ estates), even though the ward for whom the conservator had been appointed had died. The Court held that even after the ward’s death, the conservatorship proceeding and the ward’s decedent’s estate proceeding were separate proceedings and would remain so. In this case, the conservatorship proceeding, as to which a final settlement was still required, had been removed to circuit court by some heirs. However, the Court held that heirs do not have statutory standing under Ala. Code § 26-2-3 to remove the proceedings and, thus, the circuit court’s eventual remand of those proceedings back to probate court was proper.

In a case with potentially significant impact on certain aspects of residential subdivision developments, the Supreme Court in *Limestone Creek Developers, LLC v. Trapp, No. 1110838* (Ala., August 17, 2012), held that a contract between the developer and an investor under which the investor was to buy a number of lots in the subdivision was void because the contract had been entered prior to approval of the subdivision by the county. Section 11-24-2(a) of the Alabama Code prohibits the sale or offering for sale of lots in a future subdivision to the public prior to county approval of the subdivision. The Court did not specifically hold that this contract violated that statute per se because the developer argued that the investor was not really a member of the “public” within the meaning of the statute. However, a resolution promulgated by the county under the authority of related statutory provisions prohibited all sales prior to approval for the purpose of creating, establishing or modifying a subdivision, and the Court concluded that the contract violated this provision.

In *Regions Bank v. Lowrey, No. 1101541* (Ala., August 10, 2012), the Supreme Court held that a trustee was entitled to reimbursement of attorneys’ fees and expenses after successfully defending itself against claims of breach of fiduciary duty resulting from Hurricane Ivan damage to timberlands.

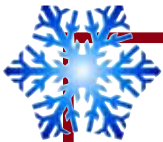

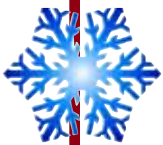
