~~An act relating to human services financing.~~ *An act to add Section 685.5 to the Insurance Code, to add and repeal Sections 12202.2 and 24330 of the Revenue and Taxation Code, and to add and repeal Article 6.7 (commencing with Section 14199.50) of Chapter 7 of Part 3 of Division 9 of the Welfare and Institutions Code, relating to Medi-Cal, and making an appropriation therefor.*

LEGISLATIVE COUNSEL'S DIGEST

SB 2, as amended, Hernandez. ~~Medi-Cal: developmental services: provider rate increases.~~ *Medi-Cal: managed care organization tax.*

(1) Existing law establishes the Medi-Cal program, administered by the State Department of Health Care Services, under which health care services are provided to qualified low-income persons. The Medi-Cal program is, in part, governed and funded by federal Medicaid Program provisions. Under existing law, one of the methods by which Medi-Cal services are provided is pursuant to contracts with various types of managed care plans. Existing law, until July 1, 2016, imposes a sales tax on sellers of Medi-Cal managed care plans.

This bill, on July 1, 2016, and until July 1, 2019, would establish a new managed care organization provider tax, to be administered by

the State Department of Health Care Services. The tax would be assessed by the department on licensed health care service plans, managed care plans contracted with the department to provide Medi-Cal services, and alternate health care service plans (AHCSP), as defined, except as excluded by the bill. The bill would require the department to determine for each health plan using the base data source, as defined, specified enrollment information for the base year. By October 14, 2016, or within 10 business days following the date upon which the department receives approval for federal financial participation, whichever is later, the bill would require the department to commence notification to the health plans of the assessed tax amount due for each fiscal year and the dates on which the installment tax payments are due for each fiscal year.

This bill would establish applicable taxing tiers and per enrollee amounts for the 2016–17, 2017–18, and 2018–19 fiscal years, respectively, for Medi-Cal enrollees, AHCSP enrollees, and all other enrollees, as defined. The bill would require the department to request approval from the federal Centers for Medicare and Medicaid Services as necessary to implement this bill. The bill would authorize the department to implement its provisions by means of provider bulletins, all-plan letters, or similar instructions, and to notify the Legislature of this action.

This bill would establish the Health and Human Services Special Fund in the State Treasury, into which all revenues, less refunds, derived from the taxes imposed by the bill would be deposited into the State Treasury to the credit of the fund. Interest and dividends earned on moneys in the fund would be retained in the fund, as specified. The bill would continuously appropriate the moneys in the fund to the State Department of Health Care Services for purposes of funding the nonfederal share of Medi-Cal managed care rates for health care services furnished to specified persons, thereby making an appropriation.

(2) Existing law imposes a gross premiums tax of 2.35% on all insurers, as defined, doing business in this state, as set forth in the California Constitution. For purposes of the Corporation Tax Law, existing law sets forth items specifically excluded from gross income.

This bill would provide that the qualified health care service plan income, as defined, of health plans that are subject to the managed care organization provider tax would be excluded from the definition of gross income for purposes of taxation under the above provisions, as

specified. The bill would reduce the gross premiums tax rate from 2.35% to 0% for those premiums received on or after July 1, 2016, and on or before June 30, 2019, for the provision of health insurance paid by health insurers providing health insurance that has a corporate affiliate, as defined, that is a health care service plan or health plan that is subject to the managed care organization provider tax imposed under the bill, as specified. The bill would require the State Department of Health Care Services to annually report specified information to the Franchise Tax Board with regard to these provisions. The bill would authorize the board to implement these provisions and would exempt the board from the administrative rulemaking process.

Existing law provides that when the laws of another state or foreign county impose certain taxes or other amounts on California insurers, or their agents or representatives, the same taxes or other amounts are imposed in this state upon the insurers, or their agents or representatives, of the other state or country doing business in this state.

The bill would prohibit the Insurance Commissioner from considering the reduction of the gross premiums tax rate under this bill in any determination to impose or enforce a tax under those retaliatory tax provisions.

The bill would provide that these provisions become operative on the later of July 1, 2016, or on the date the Director of Health Care Services certifies in writing that federal approval necessary for receipt of federal financial participation has been obtained.

(3) This bill would include a change in state statute that would result in a taxpayer paying a higher tax within the meaning of Section 3 of Article XIII A of the California Constitution, and thus would require for passage the approval of $\frac{2}{3}$ of the membership of each house of the Legislature.

~~Existing law establishes the Medi-Cal program, which is administered by the State Department of Health Care Services, and under which qualified, low-income individuals receive health care services. Existing law provides for the reimbursement of providers under the Medi-Cal program.~~

~~The Lanterman Developmental Disabilities Services Act requires the State Department of Developmental Services to contract with regional centers to provide services and support to individuals with developmental disabilities. Under existing law, the regional centers purchase needed services for individuals with developmental disabilities~~

through approved service providers or arrange for those services through other publicly funded agencies.

The bill would declare the intent of the Legislature to enact statutory changes that would stabilize funding for the Medi-Cal program and provide rate increases for providers of Medi-Cal and developmental services.

9 (c) (1) No later than December 1, 2016, and annually thereafter,
10 the State Department of Health Care Services shall provide to the

12 service plan that is subject to the tax imposed under Section
13 14199.54 of the Welfare and Institutions Code. The information
14 shall include the corporate name, address, and calendar period
15 for which each health care service plan is subject to the tax
16 imposed under Section 14199.54 of the Welfare and Institutions
17 Code, and, if applicable, the owner or owners of those health care
18 service plans.

19 (2) A qualified health care service plan with no income other
20 than qualified health care service plan income that is excluded

38 14199.50. It is the intent of the Legislature that the department
39 implement a managed care organization provider tax effective
40 July 1, 2016, to provide ongoing funding for health care and

1 prevention, minimize to the extent possible any need for new
2 reductions to the program, and meet all of the following goals:

3 (a) Generate an amount of nonfederal funds for the Medi-Cal
4 program equivalent to the funds generated by the tax imposed
5 pursuant to Article 5 (commencing with Section 6174) of Chapter
6 2 of Part 1 of Division 2 of the Revenue and Taxation Code.

7 (b) Comply with federal Medicaid requirements applicable to
8 permissible health care-related taxes, including, but not limited
9 to, Section 433.68 of Title 42 of the Code of Federal Regulations.

10 14199.51. The following definitions shall apply for the purposes
11 of this article:

12 (a) "Alternate Health Care Service Plan" or "AHCSP" means
13 a nonprofit health care service plan with at least four million
14 enrollees statewide, that owns or operates pharmacies, and
15 provides professional medical services to enrollees in specific
16 geographic regions through an exclusive contract with a single
17 medical group in each specific geographic region in which it is
18 licensed.

19 (b) "AHCSP enrollee" means an individual enrolled in an
20 AHCSP, as defined in subdivision (a), who is not a Medi-Cal
21 beneficiary.

22 (c) "AHCSP enrollee tax amount" means the amount of tax
23 assessed per countable enrollee within an AHCSP taxing tier.

24 (d) "AHCSP taxing tier" means a range of cumulative
25 enrollment of countable AHCSP enrollees for the base year.

26 (e) "Base year" means the 12-month period of October 1, 2014,
27 through September 30, 2015.

28 (f) "Base data source" means the quarterly financial statement
29 filings submitted by health plans to the Department of Managed
30 Health Care retrieved by the department as of January 1, 2016,
31 and supplemented by, as necessary, Medi-Cal enrollment data for
32 the base year as maintained by the department and retrieved as
33 of January 1, 2016.

34 (g) "Countable enrollee" means an individual enrolled in a
35 health plan, as defined in subdivision (k), during a month of the
36 base year according to the base data source. "Countable enrollee"
37 does not include an individual enrolled in a Medicare plan, a
38 plan-to-plan enrollee, as defined in subdivision (r), or an individual
39 enrolled in a health plan pursuant to the Federal Employees Health
40 Benefits Act of 1959 (Public law 86-382) to the extent the

1 *imposition of the tax under this article is preempted pursuant to*
2 *Section 8909(f) of Title 5 of the United States Code.*

3 (h) *“Department” means the State Department of Health Care*
4 *Services.*

5 (i) *“Director” means the Director of Health Care Services.*

8 *Health and Safety Code.*

9 (2) *A health plan that is owned and operated by a 501(c)(3)*

12 *enrollment in and is headquartered in either the County of*
13 *Sacramento or San Diego.*

14 (k) *“Health care service plan” or “health plan” means a health*
15 *care service plan, other than a plan that provides only specialized*
16 *or discount services, that is licensed by the Department of Managed*
17 *Health Care under the Knox-Keene Health Care Service Plan Act*
18 *of 1975 (Chapter 2.2 (commencing with Section 1340) of Division*
19 *2 of the Health and Safety Code) or a managed care plan*
20 *contracted with the State Department of Health Care Services to*
21 *provide Medi-Cal services.*

22 (l) *“Medi-Cal enrollee” means an individual enrolled in a health*
23 *plan, as defined in subdivision (k), who is a Medi-Cal beneficiary*
24 *for whom the department directly pays the health plan a capitated*
25 *payment.*

26 (m) *“Medi-Cal per enrollee tax amount” means the amount of*
27 *tax assessed per countable Medi-Cal enrollee within a Medi-Cal*
28 *taxing tier.*

29 (n) *“Medi-Cal taxing tier” means a range of cumulative*
30 *enrollment of countable Medi-Cal enrollees for the base year.*

31 (o) *“Other enrollee” means an individual enrolled in a health*
32 *plan, as defined in subdivision (k), who is not a Medi-Cal*
33 *beneficiary or an AHCSP enrollee.*

34 (p) *“Other per enrollee tax amount” means the amount of tax*
35 *assessed per countable other enrollee within another taxing tier.*

36 (q) *“Other taxing tier” means a range of cumulative enrollment*
37 *of countable other enrollees for the base year.*

38 (r) *“Plan-to-plan enrollee” means an individual who receives*
39 *his or her health care services through a health plan pursuant to*
40 *a subcontract from another health plan.*

1 14199.52. (a) *The Health and Human Services Special Fund*
2 *is hereby created in the State Treasury.*

3 (b) *All revenues, less refunds, derived from the taxes provided*
4 *for in this article shall be deposited in the State Treasury to the*
5 *credit of the Health and Human Services Special Fund.*

6 (c) *Notwithstanding Section 16305.7 of the Government Code,*

- 30 (4) *Total plan-to-plan cumulative enrollment for the base year.*
- 31 (5) *Total cumulative enrollment through the Federal Employees*
32 *Health Benefits Act of 1959 (Public Law 86-382) for the base year.*
- 33 (6) *Total other cumulative enrollment for the base year that is*
34 *not otherwise counted in paragraphs (2) to (5), inclusive.*

35 (b) *Notwithstanding any provision in this article, the director*
36 *may correct any identified material or significant errors in the*
37 *data, including, but not limited to, the overall cumulative*
38 *enrollment, Medicare cumulative enrollment, Medi-Cal cumulative*

40 *Health Benefits Act of 1959 (Public Law 86-382), and other*

9 14199.54. (a) A managed care organization provider tax shall
10 be imposed on each health plan that is not an excluded plan. The
11 tax shall be imposed for the following fiscal years:

12 (1) 2016–17 fiscal year.

13 (2) 2017–18 fiscal year.

14 (3) 2018–19 fiscal year.

15 (b) The department shall compute the annual tax for each health
16 plan subject to the tax during each applicable state fiscal year
17 pursuant to Section 14199.55.

18 (c) The department shall collect the annual tax for each health
19 plan in four installments and shall determine the amount due for
20 each installment in the state fiscal year by dividing the annual tax
21 for that state fiscal year by four.

22 (d) The department shall not collect the tax imposed pursuant
23 to this article until the department receives approval from the
24 federal Centers for Medicare and Medicaid Services that this tax
25 is a permissible health care-related tax in accordance with Section
26 433.68 of Title 42 of the Code of Federal Regulations and is
27 eligible for federal financial participation. On October 1, 2016,
28 or the date the department receives that federal approval from the
29 federal Centers for Medicare and Medicaid Services, whichever
30 is later, the following activities shall commence:

31 (1) The director shall certify in writing that federal approval
32 has been received, and within five business days, the department
33 shall post the certification on its Internet Web site and send a copy
34 of the certification to the Secretary of State, the Secretary of the
35 Senate, the Chief Clerk of the Assembly, and the Legislative
36 Counsel.

37 (2) By October 14, 2016, or within 10 business days following
38 receipt of the notice of federal approval, whichever is later, the
39 department shall send a notice to each health plan subject to the
40 tax, which shall contain the following information:

1 (A) *The annual tax due for each fiscal year.*

2 (B) *The dates on which the four installment tax payments are*
3 *due for each fiscal year.*

4 (3) *A health plan shall pay the annual tax in installments as*
5 *calculated pursuant to Section 14199.55, based on a schedule*
6 *developed by the department. The department shall establish the*
7 *date that each tax payment is due, provided that the first tax*
8 *payment shall be due no earlier than 20 days following the date*
9 *the department sends the notice pursuant to paragraph (2), and*
10 *the tax payments shall be paid at least one month apart, but no*
11 *more than one quarter apart.*

12 (4) *A health plan shall pay the taxes that are due, if any, in the*
13 *amounts and at the times set forth in the notice unless superseded*
14 *by a subsequent notice issued by the department.*

15 (e) *The tax assessed pursuant to this article shall be paid by*
16 *each health plan subject to the tax to the department for deposit*
17 *in the Health and Human Services Special Fund created pursuant*
18 *to Section 14199.52.*

19 (f) (1) *Interest shall be assessed on an applicable health plan*
20 *for any amount of the managed care organization provider taxes*
21 *that are not paid on the date due at a rate of 10 percent per annum.*
22 *Interest shall begin to accrue the day after the date the tax payment*
23 *was due and shall be deposited in the Health and Human Services*
24 *Special Fund created pursuant to Section 14199.52.*

25 (2) *If a tax payment is more than 60 days overdue, a penalty*
26 *equal to the total accrued interest charge described in paragraph*
27 *(1) shall also be assessed on the applicable health plan and due*
28 *for each month for which the tax payment is not received after 60*
29 *days.*

30 (g) (1) *Subject to paragraph (2), the director may waive a*
31 *portion or all of either the interest or penalties, or both, assessed*
32 *under this article in the event that the director determines, in his*
33 *or her sole discretion, that the health plan has demonstrated that*
34 *imposition of the full amount of the tax pursuant to the timelines*
35 *applicable under this article has a high likelihood of creating an*
36 *undue financial hardship for the health plan or creates a significant*
37 *financial difficulty in providing needed services to Medi-Cal*
38 *beneficiaries.*

39 (2) *Waiver of some or all of the interest or penalties pursuant*
40 *to this subdivision shall be conditioned on the health plan's*

1 agreement to make tax payments on an alternative schedule
2 developed by the department that takes into account the financial
3 situation of the health plan and the potential impact on the delivery
4 of services to Medi-Cal beneficiaries.

5 (h) In the event of a merger, acquisition, establishment, or any
6 other similar transaction that results in the transfer of health plan
7 responsibility for all countable enrollees under this article from
8 a health plan to another health plan or similar entity, and that
9 occurs at any time during which this article is operative, the
10 resultant health plan or similar entity shall be responsible for
11 paying the full tax amount as provided in this article that would
12 have been the responsibility of the health plan to which that full
13 tax amount was assessed, upon the effective date of any such
14 transaction. If a merger, acquisition, establishment, or any other
15 similar transaction results in the transfer of health plan
16 responsibility for only some of a health plan's countable enrollees
17 under this article but not all countable enrollees, the full tax
18 amount as provided in this article shall remain the responsibility
19 of that health plan to which that full tax amount was assessed.

20 14199.55. (a) For each fiscal year, the Medi-Cal taxing tiers
21 shall be as follows:

22 (1) Medi-Cal taxing tier I shall consist of all countable Medi-Cal
23 enrollees in a health plan from zero to 2,000,000, inclusive.

24 (2) Medi-Cal taxing tier II shall consist of all countable
25 Medi-Cal enrollees in a health plan from 2,000,001 to 4,000,000,
26 inclusive.

27 (3) Medi-Cal taxing tier III shall consist of all countable
28 Medi-Cal enrollees in a health plan greater than 4,000,000.

29 (b) For each fiscal year, the other taxing tiers shall be as
30 follows:

31 (1) Other taxing tier I shall consist of all countable other
32 enrollees in a health plan from zero to 4,000,000, inclusive.

33 (2) Other taxing tier II shall consist of all countable other
34 enrollees in a health plan from 4,000,001 to 8,000,000, inclusive.

35 (3) Other taxing tier III shall consist of all countable other
36 enrollees in a health plan greater than 8,000,000.

37 (c) For each fiscal year, the AHCSP taxing tier shall consist of
38 all countable AHCSP enrollees in a health plan from zero to
39 8,000,000, inclusive.

1 (d) For the 2016–17 fiscal year, the Medi-Cal per enrollee tax
2 amount for each Medi-Cal taxing tier shall be as follows:

3 (1) The Medi-Cal per enrollee tax for Medi-Cal taxing tier I
4 shall be forty dollars (\$40).

5 (2) The Medi-Cal per enrollee tax for Medi-Cal taxing tier II
