

--- STALL RESERVATION DEADLINE APRIL 22 ---

ALL horses, including horses residing in the state of Nevada, are required to have a negative Coggins within 12 months and a 30 day veterinary health certificate. **(Make sure the health certificate lists each horse individually by the REGISTERED name).** Original certificates must be presented at show office check in to receive an exhibitor number.

The South Point Event and Equestrian Center restricts the use of refrigerators in horse stalls.

THIS IS A FIRE MARSHALL REGULATION AND IS SUBJECT TO FINES IMPOSED BY SUCH!

- ❑ Stall reservations forms **MUST** be **POSTMARKED** by April 22nd with **PAYMENT IN FULL** via check or credit card. NO OPEN CHECKS! **After May 19th, STALLS ARE NOT REFUNDABLE**
 - **ALL STALL PAYMENTS MUST BE MADE THROUGH STALL MANAGER, NOT ON SHOW BILLS!**
- ❑ Stalls will be assigned on a first come first serve basis, with priority given to event sponsors.
- ❑ Faxed stall forms are accepted with WCRC Credit Card Authorization Form. Fax: 623-670-5905
- ❑ Stalls are available for move in beginning 1:00PM, Tuesday, May 26th. Move out by 10:00AM Monday May 30th
- ❑ Stall fee includes **SIX** bags of white pine shavings per stall (including tack/storage stalls). Additional bags can be ordered at the event and may be charged to your South Point hotel room! **NO OUTSIDE BEDDING** is permitted on the grounds.

STALL RATES/CONDITIONS:

1. **STALLS:** \$250 each for the duration of the 10 day event. All stalls include 6 bags of shavings
2. **YOUTH STALLS:** \$175 horses being shown by YOUTH AND WPR RIDERS ONLY.
3. **ABSOLUTELY NO HAUL-INS! NO HORSES TIED TO TRAILERS EVER!**
4. South Point Equestrian Center Rules/Fire Marshall Regulations specify that at no time should there be feed, bedding, tack, and/or grooming items stored in stall aisles. All these items **MUST** be stored in stalls
DOGS ARE NOT ALLOWED IN THE EVENT ARENAS, HOTEL, OR CASINO AT ANY TIME. Service Dogs OK!
