## February 17, 2016

Sales Tax Collections. The Mississippi Department of Revenue has updated sales tax data through December 2015 (for sales which occurred through November). Prior to December's report, the MS Gulf Coast combined municipal sales tax base had grown in 15 consecutive months (compared to prior year). December's returns came in 4% less than prior year. It's too early to tell if this is a trend or if it is a potential precursor to recent financial unrest. Notably, the state also reported a decline in December's returns, the first in 15 months. In December, all but three cities (D'Iberville, Gautier, and Waveland) reported declines.

**Employment**. The Mississippi Department of Employment Security released preliminary estimates for its Annual Labor Force Report. Notably, MDES revises their numbers every April so this data is subject to change. Key considerations below:

- For the first time since January 2014, all three counties on the Mississippi Gulf Coast reported year-over-year increases in establishment jobs<sup>1</sup>.
- Overall the combined Mississippi Gulf Coast reported 700 more jobs in December 2016 than it did prior year. If the loss in construction jobs in Jackson County (as a result of Chevron plant completion) is factored out, overall growth would have been closer to 1,300 jobs.
- The number of employed individuals living in the three coastal counties increased by 8,560.

**Tourism**. The Mississippi Department of Revenue has only updated its special tax tables through October, but leading up to then special tourism taxes had exceeded prior year in seven of eight months. Gaming finished its year at \$1.143 billion, up \$64 million from prior year and completing its best year since 2008. Notably, gaming revenues were up \$50 million through October so it is too early to tell whether Scarlet Pearl grew the market.

**Real Estate**. Residential permits filed in three coastal counties totaled 460 in the fourth quarter of 2016, compared to 314 same quarter prior year. This represents the most active quarter for residential permitting on the Mississippi Gulf Coast dating back to 2011. (source: Treen Reports). The number of commercial permits applied for was flat to prior year, with Harrison County reporting an increase. The value of commercial permits applied for was \$24.5 million, compared to \$28.2 million prior year.
