The Founders and their Vision

Michele Calder and Jody Shulman, both of U.S. Legal Support, always have exhibited a true passion to help those in need. Somehow, in addition to their "day jobs," they manage to make a showing at most events around town, whether legal, cultural, or social. And recently, they brought a new idea to life and launched their own organization entitled "Make a Difference Miami." Their organization has two key goals:



- 1. to raise money from both the legal and business communities; and
- 2. to bring awareness about the importance of fundraising for Miami-Dade's pro bono legal-services organizations.

Michele and Jody believe that by banding together and showing strength in numbers, we will help those in need to truly make a difference in Miami.

The Inspiration and the Promise

Throughout the past year, Michele and Jody were awed and inspired by the hard work of Legal Services of Greater Miami and Dade Legal Aid. As a result, they decided to start a grassroots effort to not only raise funds, but also to raise awareness of the need for both of these legal services organizations. The springboard for "Make a Difference Miami" was hearing former Florida Bar President Eugene Pettis voice his strong belief that the business community should step up to the plate and help legal services organizations. Michele and Jody understood that swift action was needed, and "Make a Difference Miami" was born.

Michele and Jody have agreed to personally donate \$1 to "Make a Difference Miami" through May 31, 2016, each time a U.S. Legal Support court reporter is employed to cover a deposition or hearing for a Miami-based law firm that is part of either Michele or Jody's portfolio. Even better, <u>U.S. Legal Support</u> is matching those donations!

Jody said: "We realize this was an enormous undertaking, but someone had to take the first step. Michele and I decided that each month we will personally donate to both organizations. Although we are only two people, we feel that it is important we try, no matter how small of an impact it will make. Maybe the community will join forces for such a worthy cause."

The Community Being Served

Legal Services of Greater Miami and Dade Legal Aid provide pro bono legal services to over 35,000 individuals in Miami-Dade County annually. But, this number represents only a small percentage of those individuals who actually need free legal help. Michele and Jody recognized that, especially in light of recent financial blows to pro bono legal services, focusing on fundraising efforts is critical. Miami-Dade FAWL congratulates Michele and Jody on this tremendous accomplishment. We are so proud to see you make your dream a reality, and we are even prouder that you are doing something that will help so many people in our community.

Two Miami-Dade FAWL Members, Hon, Jason E. Dimitris Miami-Dade FAWL Honored with The Florida Bar's and Avana N. Harris. Are Named as Finalists for Seat on **Miami-Dade Circuit Court Bench**

Of the six finalists named by the Eleventh Circuit Judicial Nominating Commission (JNC) for a seat on the Miami-Dade Circuit Court Bench, two are Miami-Dade FAWL members.

Hon. Jason E. Dimitris has sat on the Circuit's County Court bench since 2013 and Ayana N. Harris has been an assistant federal public defender for the Southern District of Florida since 2008. Both were named as finalists for the Miami-Dade Circuit Court seat left vacant by the resignation of Hon. Victoria S. Sigler, who served on the Circuit Court bench for 15 years, previously having served as a County Court Judge for five years.

Miami-Dade FAWL Directors and Co-Chairs of the Accessibility Committee Courtney Engelke and Stephanie Moot organized the inaugural Call to Action Diversity Summit, held on November 7,



2014. Along with Disability Independence Group, Inc., Miami-Dade FAWL and the DCBA hosted the Summit, which focused on the inclusion of persons with disablities in bar-related activities. The event hosts asked each voluntary bar organization in Miami-Dade County to send a representative to the Summit, which was sponsored, in part, by a grant from The Florida Bar. Panelists Herman Russomanno III (former DCBA President), Courtney Engelke, Stephanie Moot, and David Baghdassarian, educated attendees from voluntary bar organizations on how to develop best practices to ensure that persons with disabilities can fully participate in hosted events.

Google and Microsoft Will De-Index Revenge Porn and Remove Links to Revenge Porn Images From its Search Engines, a Huge Victory for Victims and Advocates

Individuals who discover that their intimate photographs and/or videos have been distributed and disseminated online without permission are now able to get search results that point to "revenge porn" removed by both Google and Microsoft. These new policies will not remove the actual images from websites, but the deindexing will prevent a victim's search results from being flooded with nonconsensual pornography.

On Friday, June 19, 2015, Amit Singhal, Senior Vice President of Google Search announced the new removal policy on the company's Google Public Policy Blog:

...revenge porn images are intensely personal and emotionally damaging, and serve only to degrade the victimspredominantly women. So going forward, we'll honor requests from people to remove nude or sexually explicit images shared without their consent from Google Search results. This is a narrow and limited policy, similar to how we treat removal requests for other highly sensitive personal information, such as bank account numbers and signatures, that may surface in our search results.

Microsoft soon followed suit and on Wednesday, July 22, 2015, Jacqueline Beauchere, Microsoft's Chief Online Safety Officer, announced its removal policy on the Microsoft On the Issues Blog:

Unfortunately, revenge porn is on the rise across the globe. It can damage nearly every aspect of a victim's life: relationships, career, social activities. In the most severe and tragic cases, it has even led to suicide ... Much needs to be done to address the problem. As a first step, we want to help put victims back in control of their images and their privacy. That's why Microsoft will remove links to photos and videos from search results in Bing, and remove access to the content itself when shared on OneDrive or Xbox Live, when we are notified by a victim.


BROADWAY IN MIAMI WITH MIAMI-DADE FAWL
