Market Briefing for Exporters

With a population of 1.3 billion, China recently became the second largest economy and is increasingly playing an important and influential role in the global economy. It is the third top destination for U.S. Exports after Canada and Mexico. China will likely hold on to its status as a top export market for the U.S. in the next two decades, along with Canada and Mexico, according to HSBC's research. China is now the destination for 7% of U.S. exports, up from 1% a decade ago. By 2030, about 14% of U.S. exports will be purchased by Chinese customers, the bank predicts.
