Oversee evaluation and reporting of outcomes associated with all of the above.

# Oversee Director (GPL) for the Organization of Resident Representatives

Ensure effective management of activities planned by and implemented by the ORR on behalf of resident physicians. Oversee creation of a strategic plan for the ORR and successful implementation of the plan with attention to alignment of planned activities with the overall strategic goals of the Association. Oversee evaluation and reporting of outcomes associated with the projects and programs of the ORR and those created in support of this constituent group.

## Oversee staff member who represents the AAMC on the IPEC Institute Planning Committee

Ensure successful planning and implementation of Interprofessional Education Collaborative Institution and oversee evaluation and reporting of outcomes associated with the activity. Act as liaison between staff member serving on the planning committee and the Chief Medical Education officer to ensure alignment with goals and strategic plans of the Interprofessional Education Collaborative.

Partner with Director of Strategic Initiatives in Medical Education to ensure successful implementation of annual AAMC Medical Education Meeting and of the Virtual Medical Education Meeting

Support the Director of Strategic Initiatives in Medical Education, sharing responsibility and completing projects as requested by the Chief Medical Education Officer or by the Director of Strategic Initiatives on behalf of the CMEO to ensure the success of these meetings.

Participate in and represent the CMEO as requested on other educational project within the cluster and in collaboration with other clusters

Contribute to/lead educational committee, working groups, retreats as appropriate to achieve strategic goals of the Medical Education Cluster and of the Association. Represent the Cluster and/or CMEO in educational meetings of external and/or partner organizations.

### Qualifications:

Doctoral degree; MD or PhD or equivalent combination of education or experience

12 years of work experience required, 12+ preferred

Advanced knowledge of medical education and of the domains of the work of educators (teaching, learner assessment, curriculum development, educational leadership and administration), of the organization of education and educational programming across the continuum and in medical schools and teaching hospitals and health systems, and of educational theory and scholarship/literature.

The successful candidate has likely held a significant educational leadership position in a medical school of teaching hospital and health system.

Advanced communication and leadership skills including excellent organizational, time management and priority setting skills.

Able to handle multiple complex projects and initiatives simultaneously.
