

## Head, Division of Infectious Diseases Department of Medicine Oregon Health & Science University

The Department of Medicine at Oregon Health & Science University seeks applications for the role of Head, Division of Infectious Diseases. The division head has overall responsibility for providing strategic direction and effective leadership to the division, while advancing the clinical, educational, and research missions of the School of Medicine. The division head will be expected to grow and develop the division's research enterprise, with a specific focus on physician-scientists, in addition to sustaining and growing the existing comprehensive clinical and educational programs. The division head will also work closely with the Chair and the clinical enterprise to develop and implement innovative models of high value clinical care, in accordance with our mission to improve the health of the population of the state of Oregon.

The Division of Infectious Diseases provides all aspects of comprehensive, full-service clinical service to the OHSU Hospital as well as the closely affiliated VA Portland Healthcare System. Services include consultation in infectious diseases and transplant infectious diseases, infection control, antimicrobial stewardship, multidisciplinary surgical-ID clinics with Orthopedics and Neurosurgery, and outpatient antibiotic administration programs, at both OHSU and the VA. We provide outreach expertise to providers throughout the region, as well as inpatient consultative services to complex patients on inpatient wards and intensive care units. Our educational program includes a highly successful infectious diseases fellowship program.

As the only academic medical center in Oregon, OHSU is a leader in tertiary and quaternary clinical care, with over 30,000 admissions per year, and many specialized care centers including the Knight Cancer Institute and the Knight Cardiovascular Institute. OHSU grants doctoral degrees in medicine, nursing and dentistry, and hosts over 1100 residents and fellows each year. More than 1100 principal investigators brought in \$ 355M in research grants last year, and OHSU ranks consistently in the top 25 for NIH funding. A large number of research institutes and core research facilities are available for collaboration and services, including the renowned Vaccine and Gene Therapy Institute, and a rapidly expanding global health research enterprise. OHSU is physically linked via skybridge with the Portland VA, which also features vibrant educational and research programs, and is the academic home to many departmental faculty. The Portland VA serves a large number of veterans with HIV and Hepatitis C.

The successful candidate will be a respected academic infectious diseases physician-scientist with substantial experience in research, clinical care, education, and administrative leadership. We are specifically seeking an individual with a demonstrated ability to maintain an externally funded research

program, and the ability to nurture younger physician-scientists. We are particularly interested in applications from individuals experienced in interdisciplinary translational research, and candidates with scholarly experience in areas related to global health. Candidates must possess an MD degree or equivalent and active board certification in Infectious Diseases, and be eligible to obtain clinical privileges and an unrestricted license to practice in Oregon. Academic appointment will be commensurate with experience, at the Associate Professor or Professor level.
