Opportunity Overview:

We are seeking an exceptional leader to serve as the Vice President of Clinical Quality, and to work with University of Minnesota Health leadership to establish and **oversee all aspects of clinical quality, patient safety, infection control** and other related safety initiatives. The successful candidate will develop/maintain the infrastructure necessary to support the organization, and will report directly to the CEO of the University of Minnesota Physician (UMP), and co-President of University of Minnesota Health (M Health). Other responsibilities include: serves as a key advisor to the all leaders on matters related to clinical quality and patient safety; assesses external trends in clinical quality and patient safety and recommends organizational direction and targets for University of Minnesota Health hospitals and clinics to achieve overall performance goals; works collaboratively with his/her peers to prioritize quality initiatives, broadly communicate quality improvement goals, maintain accreditation, and collaborate with clinical care and service line teams to meet/exceed all regulatory, quality and safety requirements; works with health care leaders outside of the organization to improve quality and patient safety across the continuum of care; champions commitment to a culture of safety by supporting a safe, blame-free environment, and engagement of all members of our organization in achieving our goals.

The VP of Clinical Quality will lead a diverse, multi-disciplinary organization to improve internal quality and influence quality outcomes throughout the continuum of care. He/she will collaborate, working across boundaries, to develop synergies with the broader Fairview Health System, UMPPhysicians, and the University of Minnesota. As an inspiring forward thinker, the successful candidate will take the University of Minnesota Health to the next level of linking our culture of quality and patient safety to the transformation of care. He/she will serve as an expert in clinical quality, patient safety, and quality improvement and will translate that expertise into clear and implementable goals and processes for the organization by the achievement of top decile performance in national measures of clinical quality. He/she will assess risk issues and advise the organization on changes necessary to reduce or mitigate risk. The VP of Clinical Quality will work collaboratively with the Medical School and all training programs to incorporate quality activity into their programs.
